



ORDER

WHEREAS, a joint resolution for orderly annexation was adopted by the City of Jackson and the Town of Des Moines and duly accepted by the Minnesota Municipal Board; and

WHEREAS, a resolution was received from the City of Jackson indicating their desire that certain property be annexed to the City of Jackson pursuant to M.S. 414.0325, Subdivision 1; and

WHEREAS, M.S. 414.0325 states that in certain circumstances the Minnesota Municipal Board may review and comment, but shall within 30 days order the annexation of land pursuant to said subdivision; and

WHEREAS, on December 13, 1988, the Minnesota Municipal Board has reviewed and approved the resolution for orderly annexation;

IT IS HEREBY ORDERED: That the following described property is hereby annexed to the City of Jackson, Minnesota, the same as if it had originally been made a part thereof:

That portion of the East Half of the Northwest Quarter (E1/2NW1/4) of Section 23, Township 102 North, Range 35 West, lying South of the


South shore line of the Des Moines River and North of the North line of Springfield Parkway (a/k/a Jackson County Highway #14) in Jackson County, Minnesota.
