



WHEREAS, a joint resolution for orderly annexation was adopted by the City of Aitkin and the Town of Aitkin and duly accepted by the Minnesota Municipal Board; and

WHEREAS, said joint resolution requested that certain property be annexed to the City of Aitkin pursuant to M.S. 414.0325, Subdivision 1; and

WHEREAS, M.S. 414.0325 states that in certain circumstances the Minnesota Municipal Board may review and comment, but shall within 30 days order the annexation of land pursuant to said subdivision; and

WHEREAS, on August 1, 1989, the Minnesota Municipal Board has reviewed and accepted the resolution for orderly annexation;

IT IS HEREBY ORDERED: That the following described property is hereby annexed to the City of Aitkin, Minnesota, the same as if it had originally been made a part thereof:


That part of Aitkin Township Road No. T-119 lying northerly of a line that bears North 89 degrees 06 minutes 30 seconds East from the southeast corner of said

minutes 30 seconds West.
