
The Minnesota Municipal Board has now processed and approved the above ordinance in accordance with Minnesota Statutes, Chapter 414, and the Rules of Procedure.



ORDINANCE NO. 090-226

An Ordinance Annexing Certain Unplatted Land From Empire Township Pursuant To  
Minnesota Statutes §414.033(5)

THE CITY COUNCIL OF THE CITY OF FARMINGTON, MINNESOTA HEREBY ORDAINS AS FOLLOWS:

SECTION I:

The property described below is hereby annexed  
to the City of Farmington pursuant to Minnesota

Statutes §414.033(5), to wit:

The South 200 feet of the West 80 feet of the East 940  
feet of the South 1/2 of the Southeast 1/4 of Section  
30, Township 114, Range 19 West, all in Dakota County,  
Minnesota.

SECTION II:

The City Administrator is hereby directed to  
file certified copies of this Ordinance with

the Minnesota Secretary of State, the Minnesota Municipal Board, the Dakota  
County Auditor, and the Empire Town Board.

SECTION III:

This annexation shall be effective at such  
time as this Ordinance has been approved by

the Minnesota Municipal Board and the Ordinance has been published in the official  
newspaper.

SECTION IV:

After adoption, signing and attestation, this  
ordinance shall be published one time in the

official newspaper of the City and shall be in effect on and after the day  
following such publication.
