

AN ORDINANCE TO EXTEND THE BOUNDARIES OF THE VILLAGE OF SPOONER, MINNESOTA, TO INCLUDE THE TOWNSITE OF EAST BEAUDETTE AND OTHER LANDS.

WHEREAS, The following petition has been this day presented to the village Council of the Village of Spooner, Beltrami, and state of Minnesota:-

"To the Honorable, the Village Council of the Village of Spooner, in the County of Beltrami and state of Minnesota.

We, the undersigned, a majority of the freeholders of the territory hereinafter described, do hereby petition your honorable body to extend the boundaries of the said Village of Spooner so as to include the following, to-wit:-

Beginning at the center quarter post between section One (1) and Two (2) in Township One hundred and sixty (160) N. Range Thirty one (31), W. 5th P. M. thence North along said section line to the Town line between Townships One hundred sixty (160) and One hundred sixty one (161) Range Thirty one (31); thence East along said Township line to where the same intersects the Rainy River; Thence in a Westerly direction along the meandered line of the said Rainy River to where the same intersects with the meandered line of Beaudette River; thence in a southerly direction along the East meandered line of said Beaudette River to where the same intersects with the East and West quarter line of section Two (2), Township One hundred sixty (160), N. Range Thirty one (31), W. thence East along said quarter line to the quarter post between sections One (1) and Two (2), Township One hundred sixty (160), N. Range Thirty One (31) which was the place of beginning.

The territory embraced above being Lots One (1), Two (2) and Three (3) in section Thirty six (36): Lots ~~Three (3) and~~ Five (5) in section Thirty five (35): all in Township One hundred sixty one (161) N. of Range Thirty one (31) West: and Lots One (1), Two (2) and six (6) and the south east quarter of the North east quarter of section Two (2), Township One hundred sixty (160), N. Range Thirty one (31), containing Two hundred thirty six and 15/100 acres (236.15), according to government survey. That said lots Two (2) and six (6) and said south east quarter of the Northeast quarter of said section Two include the plat of the townsite of East Beaudette, according to the recorded plat thereof on file in the office of the Register of Deeds in and for the County of Beltrami and state of Minnesota.

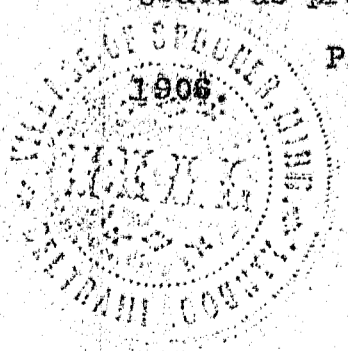
WHEREAS, It appearing that the above petitioners are a majority of the freeholders of the plated portion of East Beaudette and are owners of abutting lands described in above petition;

NOW THEREFORE, The Village Council of the Village of Spooner in the County of Beltrami and state of Minnesota, do ordain that the village boundaries of the said Village of Spooner and they hereby are extended so as to include the following abutting upon the corporate limits of the Village of Spooner and lying and being in the County of Beltrami and state of Minnesota, to-wit:-

Beginning at the center quarter ^{post} ~~corner~~ between sections 1 and 2 in Township 160 North, Range 31 West of 5th P. M., running thence North along said section line to the Town line between Townships 160 and 161, Range 31; thence East along said Township line to where the same intersects with Rainy River; thence in a westerly direction along the meandered line of the said Rainy River to where the same intersects with the meandered line of Beaudette River; thence in a southerly direction along the East meandered line of said Beaudette River to where the same intersects with the East and West quarter line of section 2, Township 160 North Range 31 West; thence East along said quarter line to the quarter post between sections 1 and 2 Township 160, North Range 31 West, which was the place of beginning; the territory embraced above being Lots 1, 2 and 3, in section 36; Lots ~~3 and 5~~ 5 in section 35, all in Township 161, North Range 31, West; and Lots 1, 2 and 6 and the SE $\frac{1}{4}$ of the NE $\frac{1}{4}$ of section 2, Township 160, North Range 31 West, containing 236.75 acres, according to the government survey; that said lots 2 and 6 and said SE $\frac{1}{4}$ of the NE $\frac{1}{4}$ of said section 2 includes the plat of the townsite of East Beaudette, according to the recorded plat thereof on file in the office of the Register of Deeds, in and for the County of Beltrami and state of Minnesota.

This ordinance shall take effect and be in force from and after its publication and filing with the secretary of state as provided by law.

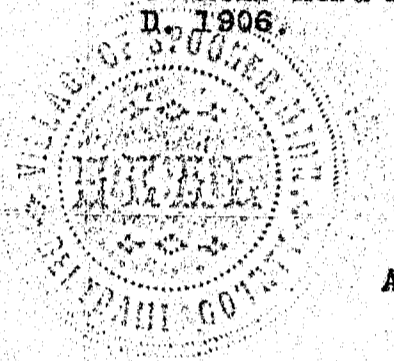
