Dear Sir:

I hereby apply for retirement from the office of Judge of the District Court of the Second Judicial District of Minnesota, as provided for by General Statutes 1923, sections 210 and 211, as amended by Laws 1927, chapter 337, and by Laws 1929, chapters 201 and 408, for the reason that I have become incapacitated physically from performing the duties of the office during the remainder of my present term or thereafter. I transmit herewith, as a part of this application, a certificate signed by my physician setting forth the nature and extent of the disability.

I am past sixty-eight years of age, and have served as a judge of the district court of the above mentioned district for more than thirty-two years.

I request that you make such investigation as you deem advisable, and that thereupon you make an order directing my retirement if the facts warrant it, and providing that I shall receive the compensation allotted to my office for the remainder of my term, and thereafter one-half of the compensation allotted to my office at the time of retirement for the remainder of my life, to be paid in the manner provided by law.



To Whom It May Concern:


I hereby certify that Judge Olin B. Lewis,


O R D E R

WHEREAS an application in writing has been duly presented to me by the Honorable Olin B. Lewis, Judge of the District Court of the Second Judicial District of the State of Minnesota, for retirement from said office under the provisions of General Statutes 1923, sections 210 and 211, as amended by Laws 1927, chapter 337, and by Laws 1929, chapters 201 and 408, which application sets forth that he has become incapacitated physically from performing the duties of the office during the remainder of his present term or thereafter, and which sets forth the nature and extent of such disability; and

WHEREAS, after due investigation and consideration of said application, it is found that said Olin B. Lewis is now a duly elected, qualified and acting Judge of the District Court of the Second Judicial District of the State of Minnesota; that he is incapacitated physically from performing the duties of his said office, which incapacity will continue during the remainder of his present term and thereafter; that the public service is suffering, and will continue to suffer, by reason of his said disability; that he is past sixty-eight years of age; that he has served as a judge of said court for more than twenty-three years last past, and that he is eligible to be retired from his said office under the provisions of the laws hereinbefore cited;

NOW, THEREFORE, I, Theodore Christianson, Governor of the State of Minnesota, do hereby order and direct the retirement of the said Olin B. Lewis as Judge of the District Court of the Second Judicial District of the State of Minnesota, to become effective forthwith, and further order and direct that he shall receive the compensation allotted to his said office for the remainder of his present term, and that thereafter he shall receive one-half of the compensation now allotted to his said office for the remainder of his life, to be paid at the time and in the manner provided by law, under and pursuant to the provisions of General Statutes 1923, sections 210 and 211, as amended by Laws 1927, chapter 337, and by Laws 1929, chapters 201 and 408.
