WRIT AND PROCLAMATION OF SPECIAL ELECTION TO
FILL VACANCY IN THE OFFICE OF STATE REPRESENTA-
TIVE FROM THE SIXTH REPRESENTATIVE DISTRICT OF
THE STATE, AND OF SPECIAL PRIMARY ELECTION TO
NOMINATE CANDIDATES FOR SAID OFFICE.

To the people of the State of Minnesota and particularly of
the Sixth Representative District of said State; to the Secret-
ary of State of the State of Minnesota; to the County Auditor of
Freeborn County of said State; to all Election Officials of said
Sixth Representative District and of the Several Precincts and
Election Districts in said Representative District; and to all
others Whom IT May Concern: GREETING:

WHEREAS a vacancy now exists in the office of State Representa-
tive from the Sixth Representative District of the State,
caused by the death of the late State Representative P. A. Peterson;
and

WHEREAS the Legislature of the State is now in session and will
be in session for sufficient length of time so that the person
elected at the special election hereinafter provided for can take
office and exercise the functions thereof immediately after his
election;

NOW THEREFORE, I, Floyd B. Olson, as Governor of the State
of Minnesota, acting under authority and direction of Section 17
of Article 4 of the Constitution of the State and the statutes in
such case made and provided, do hereby direct that a special
election be held in said Sixth Representative District on Tuesday
the 14th day of March, 1933, to fill the vacancy existing in said
office; that candidates for said office be nominated at a Special
Primary Election which shall be held on Friday, the 3rd day of
March, 1933; that affidavits of candidates for nomination to fill
the vacancy existing in said office shall be filed not later than
the seventh day before the said Special Primary Election; that
notices of said election and the primary therefor, the nomination

and election of candidates and the conduct of said elections be had and all things pertaining thereto be done, as provided by Chapter 297 Session Laws of Minnesota for 1933, and amendments thereof, and other applicable provisions of law.

IN WITNESS WHEREOF, I have hereunto caused the Great Seal of the State to be affixed and have hereunto set my hand at the Capitol in the City of St. Paul, this 20th day of February, 1935.
