GOVERNOR'S ORDER NO. 7 of 1934

ORDER PROVIDING ADDITIONAL PROTECTION FOR MIGRATORY GAME BIRDS:

Whereas the Director of Game and Fish of the Minnesota Department of Conservation has investigated the necessity of providing additional protection to migratory game birds and has found that these species are in danger of undue depletion,

Therefore, I, Floyd B. Olson, Governor of the State of Minnesota, pursuant to authority vested in me by Mason's Minnesota Statutes of 1927, Section 5640, do hereby order that Wilson snipe, (Jack snipe), rails, gallinules, ducks and geese, for which an open season has been declared, may be taken for a period of 30 days during the year 1934, on the following dates only: October 3, 4, 5, 6, 7, 10, 11, 12, 13, 14, 17, 18, 19, 20, 21, 24, 25, 26, 27, 28, 31; November 1, 2, 3, 4, 7, 8, 9, 10, 11. Shooting hours to be from sunrise to sunset, except on the date of October 3rd, which shall be twelve o'clock noon.

I do further order that a person may take in one day during the open season not to exceed 12 in the aggregate of all kinds of ducks and coots, but not more than 5 of any one, or any more than 5 in the aggregate, of the following species: eider duck, canvasback, redhead, greater scaup, lesser scaup, (bluebills), ringneck, blue-wing teal, green-wing teal, cinnamon teal, shoveller, and gadwall; and any person at any one time may possess not more than 24 ducks and coots of all species but not more than 10 of any one, or more than 10 in the aggregate, of the following species: eider duck, canvasback, redhead, greater scaup, lesser scaup, (bluebills), ringneck, blue-wing teal, green-wing teal, cinnamon teal, shoveller, and gadwall.

I do further order, declare, and prohibit, the baiting, feeding of migratory waterfowl as now permitted under Federal regulations in the State of Minnesota, except that such feeding and baiting may be permitted by the regularly constituted authority of the Department of Conservation of the State of Minnesota, or any other person authorized to represent such department, but no baiting or feeding shall be permitted outside of regular designated migratory waterfowl sanctuaries or game refuges.


I do further order that a person may take in one day during the open season, not to exceed 4 geese and may not possess more than 5 geese at any one time.


I do further order that a person may take in one day during the open season, not to exceed 12 in the aggregate of the following species: Wilson snipe (Jack snipe), rails, gallinules, and may not possess more than 24 in the aggregate of Wilson snipe (Jack snipe), rails, gallinules, at any one time.

The taking of wood duck, ruddy duck and bufflehead duck and swans, greater and lesser yellowlegs, during the year 1934 is prohibited.
