to apply for the survey
of an island in Minnesota.

Pursuant to requirements of the Commissioner of the General Land Office, Department of Interior, Washington, D.C., you are hereby notified that it is the intention of the undersigned, Hilaire Rousseau, to apply, within the legal time after service of this notice, to the Commissioner of the General Land Office, for the survey of the island in Cedar Lake, located in Section 35 Township 110 North of Range 22 West of the 5th-Principal Meridian, in the County of Rice, State of Minnesota, as public land of the United States and that like notice has been served upon all other landowners whose surveyed lands, including yours, are opposite the said island, the survey of which is being applied for and upon whom such notice it is required to be served.

You, and each of you, are further notified that it is the contention of the undersigned that the island, the survey of which is being applied for, is public land of the United States and subject to survey and disposition as such, and that any protests against the proposed survey should be filed with the Commissioner of the General Land Office, Washington, D.C., within thirty (30) days following the service of this notice; such service having been duly made upon all persons concerned, the day below written, by registered mail and return receipt requested as follows, to wit:-
