to authority in me vested by Section 5640, G. S. 1923, do hereby
order that no doe or fawn be taken in the County of Itasca,
State of Minnesota, during the season of 1936.

This order shall remain in force until
the close of the 1937 regular Session of the Legislature of the
State of Minnesota, unless sooner revoked or modified.
