Minnesota Sales and Use Tax

Minnesota Statutes, Chapter 297A

Introduction

Minnesota's sales and use tax was enacted in 1967. The sales tax is imposed on the gross receipts of businesses and individuals who sell, rent, or lease tangible personal property (goods) at retail or provide taxable services. Normally a sale is "at retail" unless the purchaser acquires the goods for resale (a wholesaler or distributor, for example), or uses the items as raw material in industrial production. Sales to parties not engaged in the business of reselling the products are considered taxable retail sales.

In addition to sales of tangible personal property, the sales tax is imposed on selected services. Some examples of taxable services are: the sale of prepared meals, the sale of electricity and other utility services, lodging at hotels, motels and resorts; building cleaning and maintenance, lawn care, car washing, car parking, laundry and dry cleaning, security services, and pet grooming.

Use Tax

Like other states with a sales tax, Minnesota also levies a complementary use tax. The use tax is imposed on taxable goods and services in cases where the vendor does not collect and remit Minnesota sales tax on the transaction. Most often, use tax applies to purchases by Minnesota customers from out-of-state vendors that legally are not required to collect Minnesota sales tax. Typically the items purchased are shipped into Minnesota from other states or countries. The use tax is also imposed on goods purchased exempt for resale but which are subsequently put to a business or personal use. For instance, removing computer hardware from inventory for the vendor's own purposes constitutes taxable use.

The sales tax is collected and remitted by the vendor; the use tax is self-assessed and paid by the purchaser.

Exemptions

All retail sales are presumed taxable unless they are specifically exempted by law. Exemptions generally fall into three categories:

1. Exempt Items

Exempt items include clothing, food products, prescribed drugs, over-the-counter analgesics, gasoline and diesel fuel used in cars and trucks, publications issued at least quarterly, certain energy efficient products, capital equipment for production industries, and motor vehicles subject to the separate motor vehicle sales tax under Minnesota Statutes, Chapter 297B.

2. Items Used for Exempt Purposes

Certain sales are exempt when the items are used for exempt purposes. Examples include materials and fuels used or consumed in agricultural and industrial production; commercial aircraft, farm machinery; industrial accessory tools, equipment, and other items having a useful life of less than 12 months; textbooks used in a course of study, residential heating fuels, and residential water utility service.

Exemptions (Cont.)

3. Sales to Exempt Organizations

Tangible personal property and taxable services sold to U.S. government agencies, certain units and agencies of local government (chiefly public school districts, city and county hospitals and nursing homes, and public libraries), and nonprofit charitable, religious, and educational organizations are exempt. The exemption of sales to exempt entities includes utility services but does not include lodging or meals.

Explanation of Data

The information in this report is based on the tax returns (form ST-1) of sales and use tax permit holders for the sales months of January through December 2000.

Each vendor is assigned an industry code according to the principal business activity reported. The industry codes for 2000 were based on the 1987 revision to the U.S. Standard Industrial Classification.

Vendors doing business at more than one location in Minnesota have the option of filing a separate return for each location or of filing one consolidated return for all locations. The consolidated return shows, for each business establishment, the sales made, tax due, and location by city and county. Data for the establishments of consolidated filers were combined with data for single-location filers to produce the figures in this report.

The following is an explanation of column headings used in the report:

Gross Sales - Total sales for the year, including both taxable and nontaxable transactions.

Taxable Sales - The amount of sales subject to sales tax. Taxable sales exclude exempt items, items sold for resale, items sold for exempt purposes, and items sold to exempt organizations.

Sales Tax - The amount of sales tax reported on form ST-1. This column includes sales tax at the 6.5 percent general rate, the nine percent special rate on on- and off-sale liquor, and the 6.2 percent additional tax on motor vehicle rental. The column does not include the 6.5 percent motor vehicle sales tax. Total 2000 revenue for the vehicle sales tax was approximately \$544 million.

Total Sales and Use Tax - The combined amount of both sales and use tax reported on form ST-1. As described on page one, use tax is due on goods and taxable services sold to Minnesota customers and but on which the Minnesota sales tax was not collected by the vendor. To determine use tax alone, subtract the sales tax column from this column.

Number of Records - The number of vendors who filed one or more returns during the year. For consolidated filers, each business location is reported as one record.
