A summary of Admin's internal service fund rates for FY 2010 is attached as required by Minnesota Statutes 16B.48, Subdivision 4. Attachments include:

- Summary of percentage rate changes
- Six-year rate comparisons for each internal service fund

Business plans for each internal service fund are being provided to Kevin Lundeen and Helen Roberts.

Internal service fund revenue is generated from charges by Admin to other agencies, based on pre-approved rates that cover the cost of services and products. In most cases, internal service fund rates are compared to prices offered by other service providers and this analysis consistently demonstrates that Admin rates continue to be competitive as well as provide needed services to our customers.

Each year, business plans and rates are carefully developed. In FY 2010, due to the difficult economic climate, all internal service funds carefully analyzed actions that could be taken to reduce expenses or increase sales with the net effect of providing relief to customers. Vigorous reviews were completed by Admin's executive team and by Minnesota Management and Budget to ensure that the businesses are positioned to respond to agencies' demands, provide rates sensitive to agencies' budgets and maintain financial stability for each of the funds. Although rate reductions were not feasible in all businesses, many businesses provided rates that absorbed inflationary expenses without a rate increase. Specifically, two businesses were able to provide rates that reflect decreased costs for state agencies:

- Risk Management Workers Compensation provides a surplus rebate to premium pool participants
- Fleet Services reduced rates on individualized leases including administrative expenses

#### Special Expenses

#### Treatment of Capital Equipment
