RE: Semi-Annual Appointment Report for 7-1-2009 through 12-31-2009

The semi-annual Appointment Report, required under Minnesota Statutes 43A.04, Subd. 7, is attached. The total number of appointments is a count of specific transactions tied to various appointment categories as indicated on the attached page. One person may have several different types of appointments throughout the year, and so the report does not reflect the actual number of new employees hired.

In keeping with the recent trend, the last half of 2009 continued to reflect a decrease in overall hiring activity. This is likely a result of the implementation of hiring restrictions as well as the forecasted and current budget shortfalls agencies are managing. Following is a snapshot of the overall hiring activity for the three most recent reporting periods.

The attached report displays activity that has occurred in several different appointment categories. Overall hiring numbers (all appointment types) are down with competitive appointments continuing to show the largest decline from the previous period (-28%). Categories showing increases were emergency (+5%) and temporary unclassified (+37%) hiring, the latter reflecting an increase in hiring for financial, IT and project positions partially based on the SWIFT project at MN Management & Budget. Twenty more persons took a demotion in lieu of layoff primarily due to layoffs at the Department of Human Services. Lower numbers in routine service and temporary hiring reflected the absence of seasonal hiring in the Department of Natural Resources.
