Laws of 1992, Chapter 513, Article 4, Section 7 and Laws of 1993, Chapter 192, Section 8, Paragraph 7, require that the Commissioner of Finance shall report to the chairs of the Jobs, Energy and Community Development Finance Division, the Economic and State Affairs Division of the Senate Finance Committee, and the State Government Division of the House Appropriations Committee, those personnel costs incurred by the Office of the Governor and the Lieutenant Governor that were supported by appropriations of other agencies during the previous fiscal year.

No General Fund money was used by other state agencies to support FY 1994 personnel costs incurred by the Governor's Office.

The Department of Administration is continuing its responsibility for the costs of Plant Management duties at the Governor's residence. An Administrative Order provides reimbursement of salary costs for a groundskeeper/general maintenance position. Those costs total \$29,179.51 for FY 1994.

In addition, the Governor's Office had an inter-agency agreement transferring a staff member to the Metropolitan Waste Control Commission to perform work on the Commission's behalf. That agreement ended August 15, 1994.
