Overall Project Outcome and Results

The Minnesota DNR Division of Fish and Wildlife implemented or provided oversight for infrastructure management and habitat restoration on lands acquired by partners to become State Wildlife Management Areas (WMA) to ensure that DNR did not incur a significant short-term liability for initial site development. Wildlife staff coordinated with and provided technical guidance to partners in preparing initial site management and restoration plans and in implementing these plans on lands acquired in Areas 1, 2, 3, 4, 5, 6, 7, 8, 9, 10 & 11. While the amount and type of work that would be accomplished was dependent on the acquisition success of partners, DNR estimated that 490 acres of habitat or facilities would be developed; the final total was 415 acres.

Infrastructure management was the primary need of the three new tracts acquired by partners in Project Areas 3, 7, and 10. This work included but was not limited to boundary surveys, boundary signing, public access, and parking lot and user facilities. Habitat restoration included but was not limited to grassland development or improvement. The work was accomplished by DNR staff, or through contracts with local vendors. The three new tracts covering over 415 acres acquired by partners now have cover, and are signed, posted, and open for public use.

Digital boundary, habitat inventory and facilities files were developed as part of the management plans and incorporated into the Minnesota WMA system. This information is also available on the DNR web site at www.dnr.state.mn.us.

March 22, 2006

Approval was received on April 6, 2006 to move \$45,700 in unencumbered funds from this work program to 4a, Prairie Heritage Funds and Critical Lands Conservation Initiative. Development of new WMAs is contingent upon partners acquiring land in a timely manner. Because of delays in completing these acquisitions, we will be unable to complete the required development work by the existing project end date of June 30, 2006. During Habitat Corridors Partnership Phase III, work program 4a will move \$45,700 to work program 2g for development work.

\$4,850,000. Restoring Minnesota's Fish and Wildlife Habitat Corridors - Phase II \$2,425,000 the first year and \$2,425,000 the second year are from the trust fund to the commissioner of natural resources for the second biennium for acceleration of agency programs and cooperative agreements with Minnesota Deer Hunters Association, Ducks Unlimited, Inc., National Wild Turkey Federation, Pheasants Forever, the Nature Conservancy, Minnesota Land Trust, the Trust for Public Land, Minnesota Valley National Wildlife Refuge Trust, Inc., U.S. Fish and Wildlife Service, U.S. Bureau of Indian Affairs, Red Lake Band of Chippewa, Leech Lake Band of Chippewa, Fond du Lac Band of Chippewa, USDA-Natural Resources Conservation Service, and the board of water and soil resources to plan, restore, and acquire fragmented landscape corridors that connect areas of quality habitat to sustain fish, wildlife, and plants. As part of the required work program, criteria and priorities for planned acquisition and restoration activities must be submitted to the legislative commission on Minnesota resources for review and approval before expenditure. Expenditures are limited to the 11 project areas as defined in the work program. Land acquired with this appropriation must be sufficiently improved to meet at least minimum habitat and facility management standards as determined by the commissioner of natural resources. This appropriation may not be used for the purchase of residential structures unless expressly approved in the work program. Any land acquired in fee title by the commissioner of natural resources with money from this appropriation must be designated: (1) as an outdoor recreation unit under Minnesota Statutes, section 86A.07; or (2) as provided in Minnesota Statutes, sections 89.018, subdivision 2, paragraph (a); 97A.101; 97A.125; 97C.001; and 97C.011. The commissioner may so designate any lands acquired in less than fee title. This appropriation is available until June 30, 2006, at which time the project must be completed and final products delivered, unless an earlier date is specified in the work program.

August 3, 2006

Initial development work on the three sites has been completed. Most of this work was for facility development as two of the sites had some existing cover.

March 22, 2006

As of this date we have been notified of three parcels acquired by partners that will be turned over to DNR for development and management as WMAs. Initial Development Plans (IDPs) have been submitted and funds encumbered.

November 23, 2004

As of this date we are still using Phase I dollars and have not spent any Phase II funds.

September 10, 2004

As of this date we are still using Phase I dollars and have not spent any Phase II funds.

April 28, 2004

As of this date we are still using Phase I dollars and have not spent any Phase II funds.

IV. OUTLINE OF PROJECT RESULTS:

Result 1: Initial Site Development

Description: Conduct site reviews of all acquired lands and prepare digital boundary, habitat and facilities files for inclusion into the DNR WMA GIS. Coordinate with Partners and Area Wildlife Managers to prepare detailed initial restoration and management plans for each new WMA. Provide technical assistance to partners in implementing management plans and summarize accomplishments in Areas 1,2,3,4,5,6,7,8,9,10, & 11. The exact number of plans will vary depending on the success of each partner in acquiring lands. DNR staff will implement management and habitat practices as outlined in the management plans on an estimated 490 acres of land acquired by partners. Implementation will include the purchase and on the ground installation of facilities and habitat materials (e.g. seed, seedlings, water control structures, etc.) using contracts, labor and equipment provided by local partner chapters and/or DNR personnel and equipment. The exact quantities will be determined by the amount and type of land acquired by the partners.

March 22, 2006

We are requesting a work program amendment to move \$45,700 to 4a, Prairie Heritage Funds and Critical Lands Conservation Initiative. DNR will not be able to spend all of the funds originally allocated to this work program due to the lag time between acquisition and development of new WMAs. During Habitat Corridors

Partnership Phase III, work program 4a will move \$45,700 to work program 2g for development work.

September 9, 2004 Amendment

On September 19, 2004 a work program amendment was approved that redefined budget items to simplify reporting and make the activities included consistent with the state accounting system. This change also made the Phase II budget consistent with the budgets for Phases I and III.

The boundary survey and posting have been completed, and a parking lot constructed. An access trail has also been improved.

Three IDPs have been completed, and some grass seed needed for restoration on Grant Coyour WMA has been purchased.

VI. PAST, PRESENT AND FUTURE SPENDING:

A. Past Spending: Minnesota DNR Division of Wildlife spends approximately \$8.3 million annually for habitat restoration and management on Wildlife Management Areas. The Division of Wildlife was appropriated \$560,000 for Wildlife Area Management (2g) in the fiscal year 2001 Restoring Minnesota's Fish and Wildlife Corridors.

B. Current and Future Spending: It is anticipated that most initial management and habitat restoration costs will be born by this project. Some use of existing Game & Fish funded personnel and equipment may be necessary for efficient implementation of field projects and GIS data capture. Salaries and expenses for the DNR Division of Wildlife's Project Manager are funded by the Game & Fish fund.

Larger habitat restorations that go beyond the scope of initial improvements and long term habitat maintenance costs will be considered from DNR Game and Fish funds, General Funds, Heritage Enhancement and bonding sources.
