#### **Overall Project Outcome and Results**

Four Native Prairie Bank perpetual easements (223 acres) were acquired by the DNR with ETF funding, and one fee-title acquisition (904 ac) was completed with TNC funds for this project.

Native prairie is Minnesota's most endangered natural habitat type. We once had over 18 million acres of prairie; today less than one percent remains – mostly on private land. These lands are home to more rare and endangered plants and animals than any other natural habitat - over 100 different listed species. Native Prairie Bank easements provide permanent protection for the prairie resource while keeping the land in private ownership. Easements may allow selected agricultural practices such as mowing wild hay or grazing. Land that has never been plowed, with less than 10% tree cover, and with predominantly native prairie vegetation, qualifies for the native prairie bank program. Funds were targeted to parcels in fragmented prairie landscapes that help establish larger grassland corridors. Ecologists believe larger blocks of prairie/grasslands are needed to support breeding populations of prairie birds such as greater prairie chickens and sharp tailed grouse, indicators of a functioning prairie ecosystem. TNC as a partner in this project spent an additional \$800,500 in privately raised funds to acquire prairie lands within these prairie landscapes.

#### **Project Results Use and Dissemination**

Acquisition of Prairie Bank easements in these Corridors will continue using bonding funds. In Phase III the focus will shift to habitat management and enhancement of these prairie lands (Restoring Minnesota's Fish and Wildlife Habitat Corridors/Phase III - Prairie Management, 5a)

# Legal Citation: ML 2003, Chp. 128, Art. 1, Sec. 9, Subd. 5a

**Appropriation Language:** \$4,850,000 (Env. Trust Fund) Restoring Minnesota's Fish and Wildlife Habitat Corridors Phase II - \$2,425,000 the first year and \$2,425,000 the second year are from the trust fund to the commissioner of natural resources for the second biennium for acceleration of agency programs and cooperative agreements with Minnesota Deer Hunters Association, Ducks Unlimited, Inc., National Wild Turkey Federation, Pheasants Forever, The Nature Conservancy, Minnesota Land Trust, the Trust for Public Land, Minnesota Valley Trust, Inc., U.S. Fish and Wildlife Service, U.S. Bureau of Indian Affairs, Red Lake Band of Chippewa, Leech Lake Band of Chippewa, Fond du Lac Band of Chippewa, USDA-Natural Resources Conservation Service, and the Board of Water and Soil Resources to plan, restore, and acquire fragmented landscape corridors that connect areas of quality habitat to sustain fish, wildlife, and plants. As part of the required work program, criteria and priorities for planned acquisition and restoration activities must be submitted to the legislative commission on Minnesota resources for review and approval before expenditure. Expenditures are limited to the 11 project areas as defined in the work program. Land acquired with this appropriation must be sufficiently improved to meet at least minimum habitat and facility management standards as determined by the commissioner of natural resources. This appropriation my not be used for the purchase of residential structures unless expressly approved in the work program. Any land acquired in fee title by the commissioner of natural resources with money from this appropriation must be designated: (1) as an outdoor recreation unit under Minnesota Statutes, section 86A.07; or (2) as provided in Minnesota Statutes, sections 89.018, subdivision 2, paragraph (a); 97A.101; 97A.125; 97C.001; and 97C.011. The commissioner may so designate any lands acquired in less than fee title. The appropriation is available until June 30, 2006, at which time the project must be completed and final products delivered, unless an earlier date is specified in the work program.

Lund 2: This project represents one of the few significantly sized remnants of dry prairie in the region (555 ac). Funding for the easement was provided through this project (\$48,389, 68 ac), 2003 bonding (\$336,606, 473 ac), and 2005 bonding (\$10,094, 14 ac) In addition to the high quality habitat there are also occurrences of three rare plant species: prairie moonwort - Botrychium campestre W.H.Wagner & Farrar; Hill's thistle - Cirsium hillii (Canby) Fernald; red three-awn grass - Aristida purpurea var. longiseta (Steud.) Vasey. All three are Species of Special Concern.

The easement is adjacent an existing 228 ac Prairie Bank easement, within the Lake Christina project area (several wetlands on the property have been restored), and within one of the Working Lands Initiative priority areas. The site has also been the focus of a research project relating to prairie birds and grazing. A Savory rotation grazing system was implemented on the property in the late 1970s with the assistance of the FWS.

#### Corridor #6 — Upper Minnesota River Project Area

Hantho 17: This is a 40-acre fair to good quality mesic prairie. It abuts the Hastad WPA (911 acres) which is contiguous with the Lac Qui Parle Wildlife Management Area ( $\sim$ 24,000 ac). It is ½ mile from the Hantho WMA (338 ac).

Camp Release 32: This is a 72-acre mesic and dry prairie adjacent the Minnesota River, surveyed and mapped by the MN County Biological Survey. Nearby protected lands include 1 native prairie bank easement, 1 WMA, and Lac Qui Parle State Park. 42 ac were prorated to Phase I accomplishments, 30 acres to Phase II.

Ordway Prairie - Langsjoen/Hogan (TNC). The project area in the northwest corner of Kandiyohi County) represents one of the last significantly sized remnants of dry prairie and uncultivated pasture in the region. Scattered throughout the site, there are also large areas of shallow open water and many wetlands in small shallow basins. The project area has no roads within its boundaries and it joins two other large, undisturbed areas of native habitat (Miller Hills WPA, on the east border of the project area and Freese WPA, on the south border). The Nature Conservancy's Ordway Prairie Preserve (4 miles to the northwest) and Moe Woods Preserve (1 mile to the west) are both nearby high quality natural areas. Including this large tract of uncultivated land with the already protected area of the region would increase the importance of this already valuable landscape for native habitat and wildlife.

Nearby protected lands include one native prairie bank easement within two miles, two wildlife management areas within three miles, one USFWS waterfowl protection area within one mile and one USFWS waterfowl protection area within two miles. Rare species occurrences in the area include: Kitten-tails (Besseya bulli) and prairie bush clover (Lespedeza leptostachya), and upland sandpiper (Bartramia longicauda)...

# **B.** Current Spending:

Phase I Corridor funds and 2000 bonding dollars will be expended prior to using any of Phase II funds. The 2003 bonding bill provides an additional \$1 million dollars for Prairie Bank acquisition and development. This will be used for easements with landowners both inside, and outside Corridor areas. TNC as a partner in this project expects to spend and additional \$191,600 in privately raised funds to acquire lands within these prairie landscapes. This is in addition to the expenditures outlined in TNC's Phase II project, Campaign for Conservation.

#### C. Required Match (if applicable): None

**D.** Future Spending: The long-range (50 year) goal of this program is to protect 75,000 acres of native prairie on private lands. The current, statewide average cost for a Prairie Bank easement is \$850/ac (easement payment + professional services) To meet this goal will require an estimated \$60-65 million. Future acquisition monies are anticipated to come from bonding or the Trust Fund.
