#### POINT DOUGLAS BLUFFLAND ACQUISITION

This appropriation is from the future resources fund to the department of natural resources for an agreement with the Carpenter St. Croix Valley Nature Center to purchase approximately 12 acres of blufflands in the Mississippi and St. Croix rivers. The land must be open and accessible to the public in perpetuity.

B. Status of Match requirement: None required

II Project Summary and Results

This project will fund the process of appraisal, negotiation and complete purchase of two different parcels of land consisting of approximately 10 acres in aggregate. One parcel (called the Ott parcel) is a 2.07 acre lot with minimal view of the St. Croix and some view of the Mississippi on the immediate south end of Nature center property. The value of this parcel has been appraised at \$35,000 and the owner is asking \$80,000. The second parcel (called the Pechacek Parcel) is approximately 4.11 acres of wooded land on the bluff directly adjacent to the Ott Parcel. This parcel is currently appraised at \$95,000 but this seems high in light of the appraisal of neighboring lots. Each of these parcels contain remnant native American burial mounds.

#### II PROJECT SUMMARY AND RESULTS (continued)

Once these properties are purchased in fee simple, they will be converted to wildlife habitat, added to the Carpenter Nature Center trail system for use within the Nature Center's award winning interpretive programs.

On agricultural land, conservation projects to reduce soil erosion will be constructed with the help of the Consolidated Farm Service Agency, the Washington County office of the Board of Soil and Water resources and the Natural Resources Conservation Service. These projects will directly benefit the water quality of the St. Croix and Mississippi rivers and add to the green corridors along both rivers' blufflands.

#### III PROGRESS SUMMARY

Appraisals have been completed. Negotiations are progressing slowly with both landowners.
