Overall Project Outcome and Results

It has been a productive biennium for the Nongame Wildlife Program: over 146 projects have been carried out. Statewide efforts were carried out in 2000 for a complete count of all 690 known bald eagle nests, and for the Loon Monitoring project (600 volunteers), frog and toad surveys (100 volunteers), and 22 Project WILD teacher workshops about wildlife ecology and conservation. Regional nongame specialists administer the statewide falconry permit and regulation program for licensed falconers (70 permittees) and for the regulation program for licensed falconers.

Major efforts continue for management and recovery of rare and endangered piping plovers, common terns, bald eagles, Karner blue butterflies, timber rattlesnakes, Blanding's turtles, wood turtles, northern goshawks and Topeka shiners. Extensive effort has involved providing technical expertise to county, state and federal land managers on conservation of nongame wildlife.

Extensive effort has involved providing technical expertise to county, state and federal land managers on techniques for conservation of nongame wildlife, participation in the forest planning process, designation of old growth forests, environmental review of projects that could significantly impact on nongame wildlife and endangered species, coordination and management of the research and small grants program, data management of state-listed species' occurrence records, and cooperation and funding for portions of the animal surveys as part of the County Biological Survey Program.

Project Results Use and Dissemination

The Nongame Wildlife Program staff provides over 100 public programs each year. In the past biennium, 22 Project WILD and Aquatic WILD workshops were held for 425 teacher participants. Publicity has included the production of 200,000 posters featuring lakescaping, loons and lead fishing sinkers. Over \$2,000,000 has been raised during the past two years on the Nongame Wildlife Checkoff. Twelve Venture North Stories have been done featuring Nongame Wildlife Program activities.

A. Nongame Wildlife Checkoff

M.L. 1999, Chapt. 231, Sec. 16, Subd. 13L

\$965,000 the first year and \$985,000 the second year are from the nongame wildlife management account in the natural resources fund for the purpose of nongame wildlife management. Any unencumbered balance remaining in the first year does not cancel but is available the second year.

\$5,500,000 is for the critical habitat private sector matching account under Minnesota Statutes, section 84.943; (The Section of Wildlife has allocated \$250,000 of this total as a match to donations to the Nongame Wildlife Checkoff for nongame wildlife management projects.)

This appropriation is from the trust fund to the commissioner of natural resources to accelerate the reinvest in Minnesota program activities authorized under Minnesota Statutes, section 84.943. Projects must occur in both urban and rural areas. Retroactive reimbursement for the greening the great river park project is authorized.

F. Nongame Wildlife Checkoff–Enabling Legislation

290.431 [NONGAME WILDLIFE CHECKOFF]

Every individual who files an income tax return or property tax refund claim form may designate on their original return that \$1 or more shall be added to the tax or deducted from the refund that would otherwise be payable by or to that individual and paid into an account to be established for the management of nongame wildlife. The commissioner of revenue shall, on the income tax return and property tax refund claim form, notify filers of their right to designate that a portion of their tax or refund shall be paid into the nongame wildlife management account. The sum of the amounts so designated to be paid shall be credited to the nongame wildlife management account for use by the nongame program of the department of natural resources. All interest earned on money accrued, gifts to the program, contributions to the program, and reimbursements of expenditures in the nongame wildlife management account shall be credited to the account by the state treasurer. The commissioner of natural resources shall submit a work program for each fiscal year and semiannual progress reports to the legislative commission on Minnesota resources in the form determined by the commission. None of the money provided in this section may be expended unless the commission has approved the work program.

The state pledges and agrees with all contributors to the nongame wildlife management account to use the funds contributed solely for the management of nongame wildlife projects and further agrees that it will not impose additional conditions or restrictions that will limit or otherwise restrict the ability of the commissioner of natural resources to use the available funds for the most efficient and effective management of nongame wildlife.

290.432. [CORPORATE NONGAME WILDLIFE CHECKOFF.]

A corporation that files an income tax return may designate on its original return that \$1 or more shall be added to the tax or deducted from the refund that would otherwise be payable by or to that corporation and paid into the nongame wildlife management account established by section 290.431 for use by the section of wildlife in the department of natural resources for its nongame wildlife program. The commissioner of revenue shall, on the corporate tax form, notify filers of their right to designate that a portion of their tax return be paid into the nongame wildlife management account for the protection of endangered natural resources. All interest earned on money accrued, gifts to the program, contributions to the program, and reimbursements of expenditures in the nongame wildlife management account shall be credited to the account by the state treasurer. The commissioner of natural resources shall submit a work program for each fiscal year to the legislative commission on Minnesota resources in the form determined by the commission. None of the money provided in this section may be spent unless the commission has approved the work program. The state pledges and agrees with all corporate contributors to the nongame wildlife account to use the funds contributed solely for the nongame wildlife program and further agrees that it will not impose additional conditions or restrictions that will limit or otherwise restrict the ability of the commissioner of natural resources to use the available funds for the most efficient and effective management of those programs.

IV. OUTLINE OF PROJECT RESULTS:

A. NONGAME REGIONAL PROGRAMS AND RESEARCH (Nongame Wildlife Checkoff Fund 185-600) Appropriation = \$1,950,000 (Amount budgeted = \$1,860,000\$1,934,530; \$965,000 \$871,129 in FY 00 and \$930,000 \$1,063,401 in FY 01. Balance as of 26 April 13 September 2001 = \$179,502 \$ 0.

Result 1: Northwest Minnesota Conservation Programs (Region 1) Total biennial budget: \$212,078.<u>\$212,078</u>. \$107,357 <u>\$107,357</u> for FY 00 and \$104,721 \$104,721 for FY 01. Balance = \$219 0 of 26 April 13 September 2001.

Activities have been carried out on 18 different major projects. 1. Volunteer loon surveys have been coordinated on two index areas in Becker and Ottertail Counties in both years. 2. Land acquisition has been underway/accomplished on Farm Island Aquatic Management Area in Big Turtle Lake, New Maine Wildlife Management Area, and Shell Lake Wildlife Management Area. Other acquisitions are being explored, including shoreland on Mule Lake. 3. A wildflower brochure has been published and assistance provided on publication of the Pine to Prairie Birding Trail booklet. 4. Nest surveys and nest management were carried out for the endangered piping plover on Pine and Curry Islands in Lake of the Woods. 5. Two lakescaping workshops were presented, five demonstration sites were evaluated and two lakescaping demonstration sites were presented. 6. Five wildlife tourism workshops were planned and presented. 7. A regionwide bald eagle survey revealed 130 nesting pairs in northwest MN. 8. Surveys were completed on colonial waterbirds, frogs and toads, and on three breeding bird survey routes. 9. Publicized the nongame wildlife checkoff. 10. Coordinated the region's falconry program. 11. Administered the region's program for coordination of wildlife rehabilitation with citizen volunteers, including site inspections and tests. 12. Habitat management was carried out in cooperation with DNR Area Wildlife Managers. 13. Technical Guidance was provided on DNR Area Teams on the Grand Forks Greenway, Big Bog Recreation Area, County Road projects and on the expansion of the Waskish Airport facility. 14. Forest coordination was carried out for the Pine Moraine and Agassiz Lowland Old Growth delineations. 15. Bald eagle and northern goshawk management was coordinated with biologists on the Chippewa National Forest. 16. Controversial environmental review projects were analyzed for resolution of conflicts, including the Washish Airport, Clay County gravel mining, and Turtle Lake. 17. A total of 30 public programs were given, including topics of bluebirds, bird feeding, conservation, lakescaping and judging at science fairs. and 18. Coordination with the statewide nongame wildlife program.

Result 2: Northeast Minnesota Conservation Programs (Region 2) Total biennial budget: <u>\$237,015</u> <u>\$224,030.</u> <u>\$127,015</u> <u>\$116,664</u> for FY 00 and <u>\$110,000</u> <u>\$107,365</u> for FY 01. Balance = \$ 21,330 \$ 0 as of 26 April 13 September 2001.

The regional nongame wildlife program has dealt with 13 major initiatives over the past year: 1. Coordination of the regionwide volunteer loon survey. 2. Helping coordinate donation of Bear Island on Deer Lake. 3. Habitat evaluation for black-throated blue warblers. 4. Boreal owl surveys and habitat assessment. 5. Protection and management of the common tern colony in Duluth Harbor. 6. Evaluation of hawk and owl survey techniques in St. Louis, Itasca and Carlton counties. 7. Field work and surveys on wood turtles on the St. Louis, Cloquet and Nett Rivers, including capture and marking of 73 turtles. 8. Field research on the natural history and habitat preferences for nesting northern goshawks. 9. Regionwide bald eagle surveys to determine the number of nesting pairs in the region. 10. Participation in forest planning for the Nashwalk Uplands old growth determination. 11. Forest planning for the Borders Lake subsection, including issue identification and fragmentation. 12. Environmental review regarding two golf courses, one wetland mitigation, one shore line development, one power line alignment, and one peat mining site. 13. Administration of the regional falconry program. 14. Administration of the regional wildlife rehabilitation program, including site inspections and test administration. 15. Interagency coordination involving the US Forest Service, Voyageurs National Park, Northeast Forest Resource Council, Lake Superior Wildlife Committee. And 16. Statewide coordination within the Nongame Wildlife Program.

Result 3: Central Minnesota Conservation Programs (Region 3) Total biennial budget: \$235,408 <u>\$235,734</u>: <u>\$121,031</u> for FY 00 and \$110,000 <u>\$114,703</u> for FY 01. Balance = \$48,715 \$ 0 as of 26 April 13 September 2001.

Seventeen major initiatives have been carried out as part of the Nongame Wildlife Program in Central Minnesota: 1. Coordinate the Central Minnesota Loonwatcher Survey which included participation by 151 volunteers. 2. Coordinate the volunteer activities of the Loon Monitoring Program which looks at loon status on 110 lakes in the Aitkin /Crow Wing Index Area. 3. Regionwide count of all 150 active bald eagle nests, including aerial surveys. 4. Grassland bird survey, including assessment of 518 grasslands and fields in Aitkin, Benton, Cass, Crow Wing, Morrision, Todd and Wadena counties for bobolinks and other grassland

birds. 5. Maintain and enhance two landscaping for wildlife habitat demonstration areas at the Uppgaard Wildlife Management Area and at the DNR Regional Headquarters in Brainerd. 6. Forest planning for old growth field assessment for 7 stands in the Anoka Sandplain subsection and one stand in the Mille Lacs Uplands. 7. Maintain a nongame wildlife audio-visual library of films and videotapes for use by teachers, conservation groups and the public. 8. Coordinate wildlife research and management with the Department of Defense on Camp Ripley, including projects on the red-shouldered hawk, Blanding's turtle, butterflies, dragonflies, jumping spiders, black bears, white-tailed deer, timber plants and rare plants. 9. Environmental review of the Little Falls dredging project, Highway 371 upgrading concerns, and bird mortality at communications towers. 10. Coordinate research by Elk River High School teacher Mike Niziolek on Blanding's turtles and road mortality. 11. Participated in 3 lakescaping for wildlife and water quality workshops and coordinated and assisted in planting two lakescaping demonstration sites. 12. Coordinated checking of 18 kestrel nest boxes with the MCC program on highway signs in Morrison, Benton and Sherburne Counties. 13. Administered the wildlife rehabilitation program for 22 rehabilitators in Central Minnesota, including site inspections and administration of tests. 14. Administered the regionwide falconry permit for 21_falconers in Central Minnesota. 15. Presented a wildlife tourism workshop at Manhatten Beach. 16. Educational efforts included 10 slide programs, a monthy radio program on KAXE in Grand Rapids, six radio programs, and two television programs. 17. And technical assistance and participation with the Big Island Joint Powers Board, Central Lakes College Natural Resources Advisory Committee, Worker Participation Committee, Uniform Committee, Midwest Fish and Wildlife Program Committee, Big Woods Team, Regional Old Growth Team, and Region 3 Environmental Assessment Team,

Result 4: Southwest Minnesota Conservation Programs (Region 4)

Total biennial budget: \$220,000 <u>186,433</u>. \$110,000 <u>\$103,645</u> for FY 00 and \$110,000 <u>\$82,788</u> for FY 01. Balance = \$ 14,781 \$ 0 as of 26 April <u>13 September</u> 2001.

There have been 14 major nongame wildlife program initiatives in southwest Minnesota: 1. Shorebird conservation. This included planning and conducting a three-day workshop for wildlife managers, work on a US shorebird management plan and assistance to DNR staff regarding shorebird management. 2. Regionwide bald eagle nest surveys and midwinter bald eagle counts. 3. Regionwide colonial waterbird nesting surveys. 4. Grassland management initiatives involving brush removal on Lac qui Parle WMA prairies and technical assistance to natural resource managers on prairie restoration. 5. Wildlife tourism workshop coordination for three workshops at Nicollet, Ortonville, and Lake Shetek. 6. Assistance with creation of the Minnesota River Valley Birding Trail in cooperation with the Minnesota Audubon Council. 7. Carried out the Minnesota Loon Monitoring survey for the Kandiyohi County index area, including volunteer coordination. 8. Coordination of the regionwide falconry program. 9. Coordination of the regionwide wildlife rehabilitation, including site inspections and testing of rehabilitators. 10. Field survey on Blanding's turtles in southwest Minnesota and solicitation of new records. 11. Provided environmental review services regarding kaolin mining and impacts of a new trail on a heron colony. 12. Regional coordination for management, protection and recovery of the federally listed

Topeka shiner. 13. Provided regional coordination involving release and nesting reports for trumpeter swans. 14. Becoming involved with major study of the effect of wind towers on migrating bats.

Result 5: Southeast Minnesota Conservation Programs (Region 5) Total biennial budget: \$209,242 \$184,583: \$99,242.36 \$54,080 for FY 00 and \$110,000 \$130,503 for FY 01. Balance = \$47,835 \$ 0 as of 26 April 13 September 2001. The Region 5 position for Nongame Wildlife Specialist was refilled in the spring of 2000. Jaime Edwards was hired to replace Bonnie Erpelding. Jaime was the former nongame wildlife biologist for the Iowa Department of Natural Resources. Major project initiatives in southeast Minnesota include sixteen activities: 1. Coordination of research and surveys for the endangered Karner blue butterfly in the Whitewater WMA area. 2. Regionwide bald eagle nesting counts. 3. Coordination of timber rattlesnake management and protection activities. 4. Regionwide coordination of falconry permits. 5. Regionwide coordination of wildlife rehabilitation site inspections and testing. 6. Coordination of peregrine falcon information on nesting activities, including collaboration with State Parks on falcons nesting in state parks. 7. Collection and field checks for nesting loggerhead shrikes. 8. Coordination and cooperation on research and surveys regarding Blanding's turtles at the Weaver dunes. 9. Involvement with acquisition and management of the Mound Prairie WMA in Houston County. 10. Involvement with management of the Hovslef Wildlife Management Area for nongame wildlife. 11. Coordination of a project to translate and publish the Hovslef birding journals. 12. Coordinate and carry out a workshop on wildlife tourism at Lanesboro. 13. Participation in the statewide lakescaping for wildlife workshop initiative, including the workshop at Cabela's. 14. Coordination of regionwide frog and toad surveys. 15. Participation in the environmental review relating to serious impacts on threatened and endangered species. 16. Assistance with promotion of the national CARA legislation for the benefit of nongame wildlife.

Result 6: Metro/Twin Cities Conservation Programs (Region 6)

Total biennial budget: \$227,881 \$204,897: \$117,881 \$ 113,400 for FY 00 and \$110,000 \$91,498 for FY 01. Balance = \$8,499 \$ 0 as of 26 April 13 September 2001.

Major nongame wildlife program initiatives in the Twin Cities metropolitan region include: 1. Participation in a regionwide bald eagle nesting pair count, including aerial surveys. 2. Midwinter bald eagle counts along the Mississippi and St. Croix Rivers. 3. Statewide coordination of the trumpeter swan restoration project. 4. Statewide coordination of the falconry program, and administration of the regionwide falconry permit program. 5. Administration of the regionwide wildlife rehabilitation program, including site inspections and testing. 6. Regionwide coordination of LCMR wildlife tourism activities, including presenting workshops at Marine on St. Croix and Red Wing. 7. Collaboration and planning committee for the 2001 Watchable Wildlife Conference in St. Paul. 8. Monitoring endangered cricket frog populations on Nine Mile Creek. 9. Providing technical guidance on the Metro Greenways Committee, Conservation Partners Working Group, Urban Wildlands Interface Working Group, and Region 6 Public Affairs and Monitoring and Evaluation Working Groups. 10. Provided habitat management expertise for Conservation Partners habitat restoration work at Eagle Creek, Lilydale Park, Wilder Forest, Battle Creek, and visited sites to evaluate potential for Greenway acquisition. 11. Provided environmental review services regarding impacts of a new golf course on Blanding's turtle habitat, wildlife impacts from the Highway 55 alignment, impacts of airport expansion on Mother Lake, potential hazards posed by nesting eagles at the international airport, and bat mortality at wind power facilities in SW Minnesota. 12. Facilitated at a lakescaping for wildlife and water quality workshop at Cleary Lake Park in Scott County. and 13. Regionwide surveys of colonial waterbirds and nesting loons, including exhaustive studies of why a heronry at Peltier Lake was abandoned in 2000.

Result 7: Statewide conservation initiatives, including program support for the lakescaping and wildlife tourism workshops. Total biennial budget: $\frac{260,768}{296,631}$. $\frac{27,846}{31,497}$ for FY 00 and $\frac{232,922}{265,135}$ for FY 01. Balance = $\frac{103}{50}$ as of $\frac{26}{26}$ April 13 September 2001. This budget covers additional project costs for regional activities.

The statewide Nongame Wildlife Program is administered out the DNR Central Office in St. Paul, from within the Division of Fish and Wildlife. Its major activities include: 1. Statewide coordination and direction for the entire nongame wildlife program. 2. Statewide coordination and implementation of the Project WILD and Aquatic WILD programs. 3. Direction and coordination of all publicity for the nongame wildlife checkoff, including coordination with the Department of Revenue and the U of MN Extension Service. 4. Production of educational products to be used statewide, including posters, slide programs, CDs and videos, 5. Development and dissemination of informational materials and news releases, and coordination of wildlife information with the media, including radio, television, and newspapers. 6. Coordination with and co-supervision of the regional nongame wildlife specialists. 7. Development and management of the Nongame Wildlife Programs's budget. 8. Writing and publication of books on Minnesota wildlife, including periodical updates and revisions of Woodworking for Wildlife, Landscaping for Wildlife, Wild About Birds: the DNR Bird Feeding Guide, Traveler's Guide to Wildlife in Minnesota, and Lakescaping for Wildlife and Water Quality. 9. Presentation of public programs on bird feeding, landscaping for wildlife, the nongame wildlife program, and lakescaping. 10. Administration and direction of the LCMR project on Wildlife Tourism, including carrying out 17 workshops and collaboration with the MN Office of Tourism. 11. VI. CONTEXT

This responsibility includes ensuring that the DNR is adequately managing these species on state lands. It includes educational programs like Project WILD

and research and surveys to determine the status and management needs of rare, declining, or listed nongame species. Technical assistance is provided to other agencies regarding the management and protection of nongame and endangered wildlife and for environmental review of development projects. Recent efforts involve addressing the recreational needs and the perceptions of the public as they partake in activities like bird-watching, bird feeding, wildlife tourism, wildlife photography, and other forms of wildlife recreation. This includes coordination with the wildlife recreation industry like wild bird food manufacturers.

B. **Time**: This is an operational and ongoing program in the Department of Natural Resources. Many of the responsibilities like monitoring of threatened and endangered species, loons, and colonial waterbird nesting sites are long-term. Loons and lead sinkers educational effort: \$1500. Reprint the "Get the lead out" brochure so copies could be distributed to interested citizens, anglers and lakeshore owners. This brochure was originally developed by the Office of Environmental Services and highlights the threat to wildlife that accidentally ingests lead fishing sinkers, like loons and trumpeter swans. Nontoxic sinkers are available as a non-toxic alternative.

Lakescaping and Wildlife Tourism Workshops: \$3000. Three lakescaping and two wildlife tourism workshops were held in the central Minnesota region. Expenses included mailing advertisements to recruit participant;s, preparation of slide programs, and travel to workshop sites to review facilities before the events.

Old Growth Forest evaluations: \$4000. Old growth forest evaluations were completed in the Mille Lacs Uplands and Anoka Sand Plain Subsections. Expenses included personnel time and travel. This information will be used for the old growth forest designation process and in forestry subsection planning.

Wildlife Audio-visual library: \$2,400. This library provides access to wildlife educational

materials for local groups, schools and professionals. Funds were used to purchase new videos and tapes, to cover mailing costs, brochure development and distribution and personnel time.

Landscaping for Wildlife Demonstration area, DNR Regional Headquarters at Brainerd. \$3,000. Native wildflower plantings were made at the entrance to the building and wildlife feeders were placed on the river side of the building to provide educaional opportunities to the public and users of the regional headquarters. Expenses included bird feeders, interpretive signs for plants and upgrading some of the plantings.

Nongame Wildlife Surveys: \$12,000. Surveys were conducted on great blue herons, ospreys, red-shouldered hawks, bald eagles, Blanding's turtles, grassland birds, and trumpeter swans. Expenses included travel, personnel, equipment and field supplies. Cats Indoors Campaign: \$4,000. Educational materials (posters and brochures) were obtained from the American Birding Association and distributed to animal shelters, veterinarians, and nature centers about the value of keeping cats indoors. News releases and public service announcements were also developed based on these materials.

Birds of the Byway: \$2,100. Printing costs wre covered for a reprinting of the popular "Birds of the Byway" brochure that assists visitors in the Pequot Lakes area with a self-guided tour and information on birds that can be found in the area.

Shorebird Management Training Workshop: \$16,838. Sponsored and coordinated a 3.5 day shorebird ecology and wetland management worshop focused on management needs of shorebirds. This training was provided to wildlife managers and public land managers to stimulate a broader range of options in management of wetlands in the prairie pothole region. This cooperative event involved the Minnesota Board of Soil and Water Resources, Ducks Unlimited, Minnesota Waterfowl Association, Minnesota Audubon, The Nature Conservancy, US Fish and Wildlife Service, Natural Resources Conservation Service, Friends of the Prairie, and two universities.

Shorebird Training and Public Information Materials: \$836. Preparation of slides, duplication of the manual "Fundamentals of Shorebird Migration" and purchase of slide trays.

Prairie Restoration: \$16,716. Tree removal on the Lac qui Parle Wildlife Management Area and on selected Wildlife Management Areas in the Marshall and Slayton areas.

Grassland Bird Habitat Conservation. \$10,000. Cooperative Agreement with the US Fish

and Wildlife Service. Delineation of GIS-based focus areas for grassland bird habitat conservation projects

Colonial waterbirds-survey and data compilation: \$3,286. Survey, data compilation, supplies and equipment. Contracted services for surveys of colonial waterbirds in the region. The contractor also helped compile the data and update the survey information. This augments the GIS database and can be used for long term monitoring of colonial waterbird populations. It also contributes towards site-specific and landscape-level conservation efforts.

Bat mortality study at wind towers: \$2,000. Contributed toward study of bat mortality associated with wind towers. Bald eagle mid-winter survey: \$501. Loon surveys: \$13. Landscaping for Wildlife: 104. Wildlife tourism/lakescaping coordination: \$243

Additional projects/equipment for training, survey, data entry and public education: \$5,299. Laptop computer, split coded with another funding source for field data entry and public information presentations on Power Point. Training software acquisition including Wildlife Counts Software, Frog Wizard and CD, and Bird Wizard. Projector for Power Point presentations (split coded).

Wood turtles and Blanding's turtles: \$15,200. Surveyed all or portions of the Straight, Cedar, Zumbro and Cannon Rivers for staging/ nesting turtles. Identified and monitored suitable nesting habitat for wood turtle nesting activity. Identified wood turtle habitat improvement needs on key nesting locations. Funded research in cooperation with The Nature Conservancy on Blanding's turtle use of highway culverts at the Weaver Dunes nesting area. And assisted with monitoring nesting Blanding's turtle movements at the Weaver Dunes.

Bald eagle monitoring and management: \$8,175. Conducted two aerial surveys to assess bald eagle productivity and identify new nests. Also includes survey and monitoring of the Wacouta winter roost survey.

Karner Blue butterfly research and management: \$10,900. Oak savanna restoration to enhance butterfly habitat. Split-coding for Trimble GPS to identify butterfly transect sites and habitat work. Chainsaw, girdling, and brush saw work to facilitate savanna restoration as well as prescribed burning and seeding.

Grassland and savanna habitat management: \$8000. Assisted with prescribed burning to improve nongame wildlife habitat. Population monitoring of Henslow's sparrows: \$4,000.

Co-funded a population monitoring project with DNR Division of Parks to assess the impacts of grassland habitat modifications on Henslow's sparrows at Great River Bluff State Park.

Timber rattlesnake management and education: \$18,900. Conducted two landowner workshops and one police department workshop on snake identification and proper handling techniques for rattlesnakes. Set up a rattlesnake call response system with volunteers and local police departments. Provided technical assistance and educational information to landowners on rattlesnake habitat management. Includes equipment and training for landowners to use to move snakes away from their property safely.

Additional wildlife surveys: wetland and prairie/savanna species and colonial waterbirds: \$4,000. Technical assistance to landowners on habitat guidelines: \$2,000. Bats: \$1670. Technical assistance to landowners on placement of bat boxes and construction of bat boxes for public and private land. Lakescaping. \$100. Headquarter operations: \$560. Tools and equipment for field projects.

Metro Region Fish Surveys: \$6,900. This is a cooperatively funded partnership involving the PCA and the Division of Ecological Services. Konrad Schmidt is conducting surveys of nongame fishes in the streams and rivers of the Twin Cities. During the past two field seasons, 80 sites have been surveyed and a report is being prepared.

Bat Mortality at Wind Towers: \$3,000. (Plus \$2,000 from DNR Region 4). Monitoring of bat mortality at wind towers in SW Minnesota. This is an interim study to insure continuity of data collections until the tower companies implement a two year monitoring initiative in 2001 as required by their operating permit.

Sandhill Crane Natural Area Inventory: \$5,000. Wildlife survey of the 500 acre Sandhill Crane Natural Area in Anoka County. This site is jointly owned and managed by the MN DNR, Anoka County and the City of East Bethel. Survey by Jay Hamernick.

Blanding's turtle priority habitat area delineation: \$2000. GIS mapping of four important Blanding's turtle habitat areas in the metro region including Lino Lakes and the Twin Cities Army Ammunition Plant corridor, Hugo Township, Carlos Avery WMA, and Murphy Hanrahan Park Reserve.

Wildlife Educational materials: \$4000. Purchase of educational materials to distribute or loan to the public including printing of the Carlos Avery WMA and Boot Lake SNA Bird Checklist, reprint of the Carlos Avery WMA Auto Tour Route guide, Peltier Heronry interpretive sign, American Bird Conservancy brochure on keeping cats indoors to protect songbirds, Howard Lake WMA heronry and eagle nest protection signs, and new bat videos for the Project WILD Bat Box educational kits.

Cricket Frog Survey at Nine Mile Creek: \$1000. Contract for monitoring of cricket frog presence and activity at Nine Mile Creek in Bloomington. This is the only site in the state where this endangered species is known to occur.

Peltier Heronry monitoring and management: \$2000. Monitor nesting activity of herons at Peltier Lake. Survey to determine mortality of young after the colony was deserted in 2000 from unknown causes.

Paul Hugo WMA and Hugo Township bird survey: \$2000. Conduct bird survey of the Paul Hugo WMA in Hugo Township and also survey Hugo Township for grassland bird habitat in Washington County.

Minnesota Frog and Toad Monitoring Program: \$2,000. Coordinate for survey of frogs and toads statewide through contract with the Center for Global Environmental Education at Hamline University.

Pine Bend Bluff surveys for reptiles and amphibians: \$2,000. French and Diamond Lakes area Minnesota Land Cover classification and waterbird monitoring: \$5,200. Lakescaping for Wildlife and Water Quality CD production: \$3,000. Research on Bald Eagle nesting success and human disturbance: \$7,500. Crane Creek shorebird area acquisition/management plan: \$2,000. Cats Indoors educational campaign statewide (to help protect songbird populations): \$3,500. Other projects: \$3,900

VI. CONTEXT

A. Significance: The broader and increased funding base provided by this appropriation provides the operational component for doing projects in the nongame wildlife program. The projects accomplished will provide invaluable information regarding the status and distribution of nongame wildlife species, assist in the management of those species, and provide important information other public agencies and to the public on how to protect, manage and enjoy that wildlife.

B. Time: This appropriation is for a two-year period, but the original concept of this proposal, as advanced by the Minnesota Audubon Council, is for this to be a continuing appropriation that would match nongame wildlife checkoff donations on a 1-1 basis as provided for in ML 84.943 Minnesota Critical Habitat Private Sector Matching Account.

C. Budget Context: There are no former appropriations from the trust fund to the Nongame Wildlife Program.

*Salary money-will be was used for seasonal wildlife technicians to carry out wildlife field surveys and management projects that are beyond their current 50-90% time appointment. Most of the total under "other" is for contract work by research specialists and for specialized costs like airplane and helicopter rental for wildlife surveys.

The Nongame Wildlife Program Staff will cooperate with the staff of the County Biological Survey and the Forest Bird Study whenever possible to pool efforts for more effective projects.

IX. REPORTING REQUIREMENTS: This periodic workprogram will be routinely turned in as part of the semi-annual progress reports that are provided to the LCMR for the overall Nongame Wildlife Program budget. A final work program report will be submitted by September 13, 2001.
