APPROPRIATION AMOUNT: \$900,000

OVERALL PROJECT OUTCOME AND RESULTS

Through its Shorelands Protection Program, the Minnesota Land Trust worked with landowners to secure permanent conservation easements on lands that border or contain critical riparian habitats -- specially crafting land use restrictions for each parcel of land to protect its unique shoreline features from future uses that could damage its important habitat values.

The Land Trust completed 27 conservation easements in 6 identified project areas around the State. See the attached map.

Collectively, these easements protect more than 2,847 acres of land, including 97,000 feet of shoreline. 5 easements were purchased -- each at a deeply discounted price. The remaining 22 were donated. The known value of these easements exceeds \$3,977,600 with the donated value well over \$3,608,100. The cost to the State to complete these easements through this grant was just over \$316 per acre, demonstrating the cost effectiveness of protecting land with conservation easements.

Additionally, the Land Trust prepared baseline reports for each easement, documenting the status of the property for future monitoring and enforcement. To fund this required perpetual monitoring and enforcement obligation, the Land Trust also dedicated funds to its segregated Stewardship and Enforcement Fund.

PROJECT RESULTS USE AND DISSEMINATION

With each project, the Minnesota Land Trust learned more about when conservation easements are effective protection tools, how to draft easements more effectively, and how to better manage an easement stewardship program that will ensure the effectiveness of each easement over time. Through the Habitat Corridors Partnership, the Land Trust has been able to use its increased knowledge to help others learn more about easements and easement programs. This has triggered an understanding that more formal presentations or programs on this topic are needed.

The Land Trust also disseminated information about this particular project and its results through press releases written for each completed project, through our newsletter and on our web site.

4(e) Restoring Minnesota's Fish and Wildlife Habitat Corridors; \$5,873,000 the first year and \$5,872,000 the second year are from the trust fund to the Commissioner of Natural Resources for acceleration of agency programs and cooperative agreements with Minnesota Waterfowl Association, Minnesota Deer Hunter's Association, Ducks Unlimited, National Wild Turkey Federation, Pheasants Forever, The Nature Conservancy, Minnesota Land Trust, Trust for Public Land, U.S. Fish and Wildlife Service, Bureau of Indian Affairs, Natural Resources Conservation Service, and the U.S. Forest Service to restore and acquire habitat to sustain fish, wildlife and plants. \$352,000 is for program coordination, corridor identification and mapping. \$3,343,000 is for restoration and management activities in wildlife management areas, wetland habitat, lakes, wild rice beds, grasslands and fisheries habitat. \$2,650,000 is for conservation easement programs on riparian areas, big woods forests, native prairies and wetlands. \$5,400,000 is for habitat acquisition activities on prairies, riparian areas and other fish and wildlife habitat corridors. As a part of the required work program, criteria and priorities for planned acquisition and restoration activities must be submitted to the Legislative Commission on Minnesota Resources for review and approval. Land acquired with this appropriation must be sufficiently

improved to meet at least minimum management standards as determined by the Commissioner of Natural Resources. Any land acquired in fee title by the Commissioner of Natural Resources with money from this appropriation must be designated: (1) as an outdoor recreation unit under Minnesota Statutes, Section 86A.07, or (2) as provided in Minnesota Statutes, Section 89.018, subdivision 2, paragraph (a): 97A.101; 97A.125; 97C.001; and 97C.011. The Commissioner may so designate any lands acquired in less than fee title. This appropriation is available until June 30, 2004, at which time the project must be completed and final products delivered, unless an earlier date is specified in the work program.

IV. OUTLINE OF PROJECT RESULTS:

The Minnesota Land Trust was extremely pleased with the work it was able to complete through the first phase of its Shorelands Protection Program. Overall, the Land Trust exceeded its project goals for this project, protecting 347 acres more than the initial goal of 2500 acres. However, with an average project size of just over 100 acres, it required completing more separate conservation easements than originally anticipated. This ultimately required more time to complete the projects requiring that more funding from the grant be directed for personnel. With more separate easements to monitor in the future this required that more funding from the grant be directed toward long-term stewardship on these easements as well.

The Land Trust was very successful in working with landowners financially able and willing to donate an easement over their land, purchasing only a few easements and even those were purchased at a discount. This resulted in a gift value for these donations that undoubtedly exceeds \$4,000,000. NOTE: Easement values are not known for all of the donated easements. The Land Trust obtained appraisals only for the purchased easements and knows of gifts values only when a landowner takes a tax deduction for the value of the easement.

It was clear that the Land Trust's ability to use funds from this grant to cover other project costs, including stewardship, made many of these donations possible when they would not otherwise have been so. It also seemed to be a pattern that landowners living and working on their land often needed financial incentives to be able to protect their lands with an easement.

The conservation easements accepted by the Minnesota Land Trust under this grant are generally located on the attached map referred to above. These projects are also summarized on the attached chart that includes the following information:

- Location of the project by Project Area.
- Minnesota Land Trust site and track name for the project.
- County in which the land is located and the easement recorded, including the document number assigned upon recording.

VI. PAST, PRESENT AND FUTURE SPENDING:

- A. Past Spending: The Minnesota Land Trust has expended substantial financial resources to secure conservation easements throughout the state, including numerous projects throughout three Project Areas in which we will be working. In addition, we have had programs and projects funded through Legislative Commission on Minnesota Resources in the past. However, we have not had a specifically targeted shoreline protection initiative in the past with funding available for easement acquisition.
- **B.** Current and Future Spending: This funding provided the Land Trust with an opportunity to implement its strategic plan of targeting our protection efforts and spreading our conservation activities around the state. Contacts made and work completed in this project have set the stage for additional work in the identified project areas under phases 2 and 3 of the project.
- **C. Project Partners:** The Land Trust worked with a number of other Habitat Corridors Partnership organizations in coordinating our protection efforts under this project. Connections made through the partnership have already made it easier to work with a number of partner organizations in phases 2 and 3 of this project and on other conservation initiatives.
- **D.** Time: The project was completed by June 30, 2004.

VII. DISSEMINATION

Results will be disseminated by the Land Trust in our publications and web page (**www.mnland.org**). We will also participate when possible in larger dissemination and publicity efforts of the CH-01 partnership.
