Summary

The Department of Employment and Economic Development ("DEED") has reviewed its administrative rules in accordance with Minnesota Statutes, Section 14.05, Subdivision 5. The agency has identified a number of obsolete, unnecessary, and duplicative rules in chapters 3310 and 3315 related to the Unemployment Insurance program.

Rules proposed for repeal

DEED is currently in the process of formal rulemaking to update the rules governing the Unemployment Insurance program and will propose the repeal of these unnecessary, obsolete, and duplicative rules as part of that process. Specifically, DEED will propose elimination of the following rule parts:

Rulemaking process

As required by Minnesota Statutes, section 14.131, the Department of Employment and Economic Development is currently preparing a Statement of Need and Reasonableness as part of its rulemaking process. When complete, that document will provide a more in-depth analysis of the rule parts proposed for repeal along with details on the other proposed changes to Chapters 3310 and 3315.

The agency found no other rules in other chapters that have become obsolete, unnecessary, or duplicative over the course of the last year.
