Dear Senators and Representatives:

Pursuant to 2011 Laws of Mn, 1st Special Session, Chapter 10, Article 3, Section 46, attached is the number of full-time equivalent (FTE) executive branch employees as of June 30, 2013, compared to the number on June 30, 2011.

The report shows actual FTEs for FY 2013 as compared to actual FTEs for FY 2011. The FY 2013 report shows an increase of 109.6FTEs as compared to FY 2011 FTEs. This represents an increase of 0.3 percent over two years. The report shows decreases in FTEs funded through Federal and General funds of 10.3 percent and 0.7 percent respectively. FTEs funded from Other State Funds increased 3.2 percent. The Departments of Natural Resources, Human Services and Veteran's Affairs were among the agencies with the greatest increase in FTEs. The Departments of Employment and Economic Development, Public Safety and Transportation were among the agencies with the largest losses.
