Dear Representative Dean and Senator Lourey,

Each year there are many residential service sites operated by the Department of Human Services (DHS) are redesigned, closed or relocated. Landlord issues, leasing agreements, funding, service needs and access are all reasons a site may need to be closed or relocated. Client needs or new licensing requirements may drive a redesign of a setting. Pursuant to Minnesota Statutes, section 246.128 the Minnesota Department of Human Services is to report to you the redesign, closure, or relocation of state-operated services programs. This report is attached for your review.


I would like to take this opportunity to advise you that I have assembled a Commissioner's Community Based Steering Committee. This group of internal and external professionals is advising me on a range of policy options as we move to become a safety-net provider of services to people with disabilities, particularly persons with complex and challenging problems that, in the past have made living in the community difficult.

It has been observed by many, including the Legislative Auditor in 2013, that DHS State Operated Services was serving many people with disabilities that could be served by private providers. At the same time, he reported that there are people with high needs who are not being served in the most appropriate community settings and could be served by state operated programs. We should have our experienced staff ready to serve the highest need clients, including those who present a risk to public safety.

I share this with you today because in order to create the true safety net we need to phase out serving clients who can be served elsewhere. As a result, we expect we will need to close some homes over time and repurpose others to serve different clients than are served there now. This report will serve as one method of communication about the changes we are undergoing in our community based services.
