Subject: Annual Report on Obsolete, Unnecessary, or Duplicative Rules as Required by *Minnesota Statutes*, section 14.05, subdivision 5

Dear Governor Dayton, Senators, Representatives, Revisor Timmons, Director Hubinger:

*Minnesota Statutes*, section 14.05, subdivision 5, directs the Department of Natural Resources (DNR) to report to you by December 1 of each year whether any of its rules are obsolete, unnecessary, or duplicative of other state or federal statutes or rules.

1. The Department has reviewed its rules and found that the following rules are or have become obsolete, unnecessary, or duplicative. We are not contemplating any action on this item at this time.

Minn. Rules, parts 6122.0100 to 6122.0400, concern appraising DNR leased lands adjacent to public waters. Since 1973, no leases may be issued per Minn. Stat., sec. 92.46, subd. 1a. Ownership of most of the lakeshore leased properties have been conveyed through lease sale or land exchange to private parties under two legislatively mandated programs. Three lakeshore leases remain in effect. Those three leases are located at Horseshoe Bay in Cook County. The valuation of the property and the rental payment for those three leases is as provided in Laws 2003, First Special Session, chapter 9, article 1, rather than the rules. Thus, Minn. Rules, parts 6122.0100 to 6122.0400, are unnecessary at this time. However, if the 2003 law was ever repealed, these rules would still be needed. Since there is a possibility the rules may be needed during the term of the leases (issued for lifetime of lessee and lifetime of party within second degree of kinship if the lease is transferred), we have decided to leave the rules in places and unused.

- 2. The DNR previously declared its intention to repeal or update the following obsolete rules carried forward in this report.
  - a. We will address obsolete rules in Chapter 6100 "Outdoor Recreation" in a permanent rulemaking package still under development or use the repeal process outlined in *Minnesota Statutes*, section 14.3895. We have not set a timetable for completion. Our 2012 report contains a detailed list of the obsolete rule parts.
  - b. We will address obsolete rules in Chapter 6105 "Wild, Scenic, and Recreational Rivers" in a permanent rulemaking package or use the repeal process outlined in *Minnesota Statutes*, section 14.3895. We have not set a timetable for completion.
  - c. Part 6120.3300, subpart 2, item D, establishes standards for lots of record in shoreland areas, specifically for when nonconforming lots of record may be allowed as building sites without variances from lot size requirements. These provisions are superseded by *Minnesota Statutes*, sections 462.357, subdivision 1e, (d) to (j), and section 394.36, subdivision 5. We will address this item in a permanent rulemaking package or use the repeal process outlined in *Minnesota Statutes*, section 14.3895. We have not set a timetable for completion.
  - d. Part 6115.0110 relating to annual water appropriation processing fee is obsolete and unnecessary because it is superseded by more recent statutes. We will address this item in a permanent rulemaking package or use the repeal process outlined in *Minnesota Statutes*, section 14.3895. We have not set a timetable for completion.
- 3. The DNR previously declared its intention to repeal part 6230.0250, subpart 1 (duplicate definition for "waterfowl season"); part 6232.0300, subpart 1, item B, subitem 3 (deer hunting regulations in an area of the state where bovine tuberculosis is no longer found); and part 6236.0810 (obsolete definition of wild turkey hunting permit areas). Repealers were included with permanent rules effective January 5, 2015, (Revisor's File No. R-04250) and these items are completed.
- 4. The DNR previously declared its intention to repeal chapter 6212 "Licenses and Permits" (which is obsolete in its entirety); part 6260.1500 (concerning regulation of commercial fishing on Namakan and Sand Point Lakes); and part 6280.0250 (concerning prohibition on the harvest of *Nelumbo lutea* (American lotus) in areas designated for their protection). Repealers were included with permanent rules effective December 22, 2014, (Revisor's File No. R-04114) and these items are completed.
