## Yinka.

We obtained rail traffic information from CN. I am providing here in an informal manner so that you can let us know if this information is going to meet your needs.

We identified two rail segments that would be of interest:

Segment 1 is Iron Junction to Allen Junction

Segment 2 is Allen Junction north to Nugget, the PolyMet Plant Site and Embarrass.

Trains would go south from Iron Junction towards Duluth.

Trains on these routes were identified as follows:

Segment 1: Trains in both directions between "Iron Junction" and "Allen Junction"

Year round daily: U789, U788, U791, U790, U792, U793, L594, R901

Additional trains during summer: daily: U736, U737

Segment 2: Trains in both directions between "Allen Junction" and "Nugget station" segment:

Note: There are no trains currently running. Mesabi Nugget is the only customer on that segment

and they are currently using trucks.

The short answer is eight trains per day on Segment 1 except summer and 10 train per day in the summer and no current traffic on Segment 2. The attached excerpt from a CN map may help explain this information.
