

AREA AGENCY ON AGING STAFF 2016

LAND OF THE DANCING SKY AREA AGENCY ON AGING

PURPOSE:

The Land of the Dancing Sky Area Agency on Aging is committed to supporting the dignity and independence of older adults of Northwest and West Central Minnesota. Our services include: providing advocacy and leadership in the development and support of community-based services to reduce isolation, improve access to services and to help seniors remain independent and safe in their homes for as long as possible.

SERVICE PRIORITIES:

Nutrition, congregate and home delivered meals, legal services, housekeeping, chore services, home modification, transportation services, disease prevention/health promotion, early memory care, medication management, fall prevention, Tai Ji Quan: Moving for Better Balance, Matter of Balance, chronic disease prevention, respite care and caregiver support.

Together We Are Stronger

The Land of the Dancing Sky Area Agency on Aging (LDSAAA) experienced many opportunities for growth and development of new and innovative programs that serve older adults in Northwest and West Central Minnesota. As we reflect on the close of another year we are reminded of the many regional health care and aging providers that collaborated to serve these people. Together we are stronger and we are making an impact on the communities in our region.

The LDSAAA strengthened its advocacy role through participation at the Aging Policy Day on the Hill, celebrating revisions made to the Older American's

Act established in 1965 that funds home and community supports. Area Agencies on Aging (AAA) across the nation support this effort.

We participated in Senator Klobuchar's *Supporting Our Seniors* listening sessions around our region. This was an opportunity to educate legislators on real issues facing today's older adult population. Senator Al Franken came to Fergus Falls to address the high costs of medications and hear the impact it has on older adults. Guess what? There is more work to be done. Advocacy has taken on a new challenge this year as we advocate for more funding for volunteer-based transportation, which impacts all of our home- and community-based services. Rural, older adults have limited access to services because of the distance needed to travel to access services.

Workforce issues also impact our aging providers. We will be developing closer relationships with economic developers to advocate and develop a plan to address this issue. Older Minnesotans have a right to age in place in the community of their choice. Thank you for allowing us the opportunity to work closely with older adults and their caregivers.

Healthy Living As You Age

The *Healthy Living As You Age* initiative has provided an opportunity for the LDSAAA to partner with other Minnesota AAAs and local health care providers to expand the availability of evidence-based health promotion programs across our 21 county region. Leader trainings were hosted in targeted communities that increased the number of leaders who offer A Matter of Balance, Tai Ji Quan, Chronic Disease and Diabetes Self-Management classes.

Some of our local partners in this project include LifeCare, Riverview, Sanford Health, Lake Region Healthcare, Park Rapids CHI St. Joseph's, Breckenridge, Ecumen, Living at Home programs in Warren, Park Rapids, Barnesville, Pelican Rapids, as well as Northwoods Caregivers and Lakes and Prairies Community Action.

Powerful Tools for Caregivers

A program that makes a positive difference in caregivers' lives through increased confidence in coping with caregiver demands, management of emotions and improved self-care behaviors.

Caregiver Consultant Services

Providing care for an older adult or someone with memory loss can be stressful and overwhelming. Caregiver Consultants help people assess their situations and identify strengths, concerns and issues as well as find solutions and resources to assist in providing care.

Holding a "Family Meeting"

A family meeting is a chance for spouses, children and others involved in the care of an older adult to identify needs, share responsibilities and develop a plan that will best serve the whole family. It can help build understanding about changes in an older adults health or ability to function and increase communication and sharing of caregiving responsibilities.

Senior LinkAge Line®

The Senior LinkAge Line® (SLL) continues to provide information and assistance to seniors and their families.

Our broad service areas that fall under the SLL include Phone Specialists, County Coordinators, Outreach Specialists, Pre-Admission Screening Specialists, Community Living Specialists and Volunteers.

Six Phone Specialists and eight County Coordinators helped 95 seniors save \$167,008 during Open Enrollment!

Two Pre-Admission Screening Specialists completed 5012 screens for nursing home admissions. They also followed up with people discharged after a short nursing home stay.

Three Community Living Specialists assisted 162 people return home after a nursing home stay. The savings impact per senior returning home is \$5,166 on average per month!

We also offered 13 Medicare 101 educational classes in our region. If you would like a class offered in your area call us today!

PURPOSE:

To assist communities in maintaining the services and infrastructure needed to support a robust economy and an attractive quality of life.

SERVICE PRIORITIES:

Community planning and zoning, tourism development and promotions, recreational development and geographic information system (GIS) mapping.

Supporting a Diversified and Resilient Economy

The NWRDC is charged with assisting communities through a variety of means that support a diversified and resilient economy and contribute to an attractive and compelling quality of life. Staff participate in a variety of groups, steering committees, taskforces and the like throughout the year. Even when we are doing our “normal” work program routine, there are many occasions during the year when opportunities or challenges spring up and must be addressed. The variety is endless and more than can be shared on these pages, a more complete review of our work program is available on our website at www.nwrdc.org.

In 2016, the NWRDC staff were heavily involved with comprehensive planning in the City of Fisher and Smiley Township, assisted with curriculum and seminar development for a statewide professional peer learning process, worked with the U of M RSDP on developing funding priorities, reviewed applications for community-based projects, served on an advisory board for the UMC EDA University Center to conduct economic impact analysis and applied research and collaborated with MADDO colleagues to create DevelopMN — a statewide economic development strategy for rural Minnesota. These projects, and more, are just some of the issues that we work with on an annual basis.

ECONOMIC DEVELOPMENT

PURPOSE:

To maintain and increase the population level and job base in the seven counties of Northwest Minnesota.

SERVICE PRIORITIES:

Business development, labor force development, renewable energy, promotion and planning.

Exciting Projects are a Mainstay

Helping to make people's ideas, dreams and hopes a reality is a fun and exciting part of the Economic Development field. We get to work with entrepreneurs and established enterprises who are starting new companies, expanding operations, creating innovative products, buying high tech equipment to improve efficiencies and providing unique niche items to the goods and services markets.

Grantwriting is an expanding area for the NWRDC, as staff completed successful grant applications to Minnesota Dept of Agriculture for Vertical Malt Company in Fisher to purchase equipment that will build

production capacity and provide unique customized malt products for the craft brewing industry. Craft brewing, wineries and distilleries are a growing segment of the Northwest Minnesota economy, proving that cold weather is not a barrier to making high-quality beverage products in the region. In addition, the NWRDC has consulted with other growers and individuals in putting together grant applications that address edible bean segregation and shipping, hops production, cold weather grape varietal trials, food processing, wastewater treatment and business succession planning.

The NWRDC's participation in Impact 20/20, an influential group of leaders throughout the region, led to the addition of a Housing Taskforce and the creation of a Housing Action Network to address housing shortages and barriers to housing development.

The NWRDC staff serve on the Housing and Workforce taskforces, as well as the Leadership Council of Impact 20/20.





TRANSPORTATION PLANNING

PURPOSE: To insure safe and efficient movement of people and commodities and provide an on-going forum for important transportation issues in the region. To assist MnDOT and provide input with it's planning efforts and programs.

SERVICE PRIORITIES: Direction setting, comprehensive regional planning, legislative advocacy and MnDOT project coordination.


The NWRDC has contracted with MnDOT on several projects in the past year, including a Safe Routes to School (SRTS) plan for the Ada School District, a regional transit plan for our seven county service area, coordination of a fleet of bikes that will be shared with school districts to encourage and teach kids how to properly ride and promote healthy living, as well as service on the Minnesota Freight Advisory Committee that meets quarterly in Minneapolis.

The Transportation Advisory Committee (TAC) attended a presentation by Tony Nordby from Houston Engineering on the second phase of the Oslo flood modeling project, which will focus on the hydraulic characteristics of the Red River of the North near Oslo. The project will also evaluate the

existing agricultural levees, effects of removing identified potential flow restrictions and a proposed setback levee alternative alignment.

Transit Plan

The NWRDC Transit Plan is following Federal transit laws under the FAST Act, which requires that projects selected for funding under the Enhanced Mobility of Seniors and Individuals with Disabilities program be included in a locally developed and coordinated public transit-human services transportation plan and that the plan be developed and approved through a process that included participation by seniors, individuals with disabilities, representatives of public, private and nonprofit transportation and human services providers and other members of the public. These plans are completed every five years.



Ada Safe Routes to School Plan

A plan is being drafted for the Ada SRTS program. It's goals include:

1. Enabling and encouraging children, including those with disabilities, to walk and bike to school.
2. Making biking and walking to school a safer and more appealing transportation alternative, thereby encouraging a healthy and active lifestyle from an early age.
3. Facilitating the planning, development and implementation of projects and activities that will improve safety and reduce traffic.

NORTHWEST REGIONAL ENTERPRISE LOAN FUND

PURPOSE:

To strengthen and diversify the economy by providing a source of low interest financing to businesses when credit is not otherwise available from other sources and to ensure the successful completion of activities to be financed.

SERVICE PRIORITIES:

Financing for-profit businesses which create or retain jobs, especially for the long-term underemployed or unemployed.

2016: A Year In Review

The Northwest Regional Enterprise Loan Fund saw three different companies pay loans in full during 2016. The Revolving Loan Fund (RLF) thanks those companies for their relationship with the NWRDC and wishes them the best in future endeavors.

The number of new loan applications continues to remain low, a trend that continues since 2013. The number of inquiries in 2016 is comparable to previous years but the projects seen to completion have dropped. The RLF closed one loan in 2016 for \$75,000 and committed two other loans for \$250,000 that are set to close in 2017. The RLF has seen a recent spike in inquiries during the waning months of 2016 which will set the RLF up for a great 2017. In addition to opening new loans, other

loan fund activities included loan restructuring, interest rate adjustments, payoffs, loan assistance to community economic development agencies (EDAs) and technical assistance.

We provided technical assistance in the form of information and referral to other organizations and agencies including but not limited to: Small Business Development Center, EDA University Center, Agricultural Utilization Research Institute, Department of Employment and Economic Development, Headwaters Regional Development Commission, Northwest Minnesota Foundation and the IDEA Competition.

EMERGENCY OPERATIONS PLANNING

PURPOSE: To aid Homeland Security & Emergency Management (HSEM) Region Three in the preparation, planning and implementation of activities related to regional preparedness, response and recovery.

SERVICE PRIORITIES: Utilize a specifically geared, annually evolving work program to support existing emergency management capabilities throughout Northwest Minnesota, as approved by the Emergency Management Joint Powers Board, Regional Program Coordinator and HSEM staff.

Joint Powers Board Staff

Continued our partnership with the Region Three Joint Powers Board in Northwest Minnesota in performing a variety of work tasks aiding in the regional progression of emergency management and homeland security strategies, projects and capabilities via a staff planning position.

Conference Attendance

NW MN Visitor & Recreation Guide – A guide of attractions which offer services and opportunities in Northwest Minnesota communities.




WHAT IS A REGIONAL DEVELOPMENT COMMISSION?

Regional Development Commissions (RDCs) were created by the State Legislature through the Regional Development Act of 1969. The intent of the Act was to create an option for rural units of government to supplement existing public services and coordinate specific activities of mutual concern.

Although created by the state, RDCs were left in the hands of local representatives to insure that the final design would reflect area needs and preferences.

Nine total RDCs were established to provide technical assistance to the local units of government in their region.

The Northwest Regional Development Commission was created on February 2, 1973 by the joint actions of local units of government. Programs were set up to reflect priority work items of the time and relationships were established with the state and federal agencies that could provide assistance with local projects. Programs and work priorities have changed in response to economic and social trends; but, the central mission of supporting efforts by cities, counties, townships, businesses and individuals to

improve living, working and natural resource conditions in Northwest Minnesota has remained the same.

The Commission has worked to establish a manner of operation which reflects and compliments the independent, progressive style of Northwest Minnesota. Our services include grants, business loans, technical assistance, grant writing, planning, direct client services, new program development, fiscal agent support, information and referral, creating partnerships and filling the gaps.

The West Central Initiative Foundation (WCI) performs some of the same functions as an RDC.
