

SNAPSHOT | Local Projects Requested by Minnesota Communities

2018 Public Works Bill for a Better Minnesota

In addition to the public works projects proposed by Governor Dayton, communities across Minnesota have submitted proposals for \$857 million in other urgently-needed local projects – demonstrating the significant need for substantial infrastructure investments in the upcoming legislative session. Though not part of his public works proposal, Governor Dayton believes that these projects merit state investments, and looks forward to working with the Minnesota Legislature to include many of them in a final bill during the 2018 Legislative Session. This snapshot breaks down projects that have been proposed by cities, counties, and other local government units.
