## About This Report

This report meets the requirements of Minn. Stat. (1985) 473.351, subd. 2, which through subsequent legislation in 1987 (H.F. 1315, Sec. 26, subd. 6), provided \$2 million in state funds for fiscal year 1988 for the operation and maintenance of regional parks in the Twin Cities Area.

The law requires the Metropolitan Council to "annually report to the legislature the amount distributed to each implementing agency and its estimate of the percent of operation and maintenance expenditures paid for with operation and maintenance money."

The figures for each regional implementing agency are shown on the attached table. The table shows the amount distributed in 1987; percent of the \$2 million received in 1987; 1987 expenditures for operation and maintenance of regional parks, either estimated actual or budgeted, as reported at the end of the year by each agency; distributed funds as a percent of estimated actual expenditures; and amount of distributed funds each agency spent in calendar year 1987, with annotations to show when the remaining funds will be used if they were not completely spent in calendar year 1987.
