Dear Senators, Representatives, Ms. Studders, Mr. Dunn:

We are pleased to transmit to you this report of solid waste management tax receipts for January 1999 through June 1999. This report is prepared pursuant to Minnesota Statutes Section 297H.13, Subdivision 5 (1999 Statutes). The attached schedule includes amounts:

1. Reported on tax returns for the month prior to the month of receipt;
2. Received with delinquent returns;
3. Paid because of an audit or amended return; and,
4. For June, 75 percent of the June liability for filers required to pay by electronic funds transfer. Those amounts normally would be due in the month following receipt.

Previous reports also included collections from the solid waste generator assessment and the sales tax on solid waste management services. They were repealed effective January 1, 1998. As a result, amounts collected during this reporting period were not substantial and largely represent adjustments to returns filed previously. Accordingly, we have omitted them from this report. If you would like those amounts, we will be glad to provide them to you.
