Editor's note: Leaders of both the Minnesota Senate and the House of Representatives called for a short, but productive, 1978 legislative session. The session was short - just 10 weeks, from Jan. 17 to March 24 - and productive with 341 bills passed and signed into law. And although two issues, tax relief and abortion funding, seemed to dominate the headlines, there were a number of other major issues to be heard, debated and decided. The following pages contain summaries of the major bills and a complete catalogue of all the measures passed this year.

Bill will cut over \$102 million in state taxes

A \$102 to \$105 million tax package was approved by the 1978 Legislature that will cut the income taxes of every Minnesotan by at least \$10 and will provide more relief for young families, businesses and the working poor.

Beginning with the 1978 tax year, the personal credit will be increased from \$30 to \$40 for each taxpayer, spouse and dependent. Under the 1977 tax bill, the personal credit was scheduled to increase from the current \$21 to \$30. The 1978 tax bill will boost the credit an additional \$10. The supplementary personal credits for people over 65, the blind, and the deaf will be decreased from \$30 to \$20, but the total package of personal credits for these individuals will be no lower than under current law.

In addition, the bill provides a \$50 "homemaker" credit for families in which one parent forgoes outside employment and remains in the home to care for a child under the age of 13. Families with annual incomes under \$25,000 will be eligible for this credit. The bill will also cut back a scheduled income tax increase for those having a taxable income of more than \$20,000.

Tax relief is provided for every person who pays residential heating bills. The 1978 tax bill immediately repeals the sales tax on fuels used for residential heating — which includes fuel oil, coal, wood, steam, propane gas, and LP gas. Natural gas and electricity will be exempt from the 4% sales tax during the six-month winter period only, because they are used for more than heating purposes. The exemption will be effective for the billing months of November through April.

Tax relief for business is provided by the repeal of the 2 percent excise tax now imposed on payrolls in excess of \$250,000.

The "working poor" and retired persons will also benefit under the new bill. The legislation will raise the eligibility ceiling for the "working poor" tax relief program. The program was originally designed to eliminate the income tax liability for workers at or near the minimum wage level, and the tax credit is increased according to the number of

dependents. Under the new bill, the tax relief schedule will be adjusted for inflation and increases in minimum wage levels. The new ceiling will be \$4,800 for four-member households, and \$8,900 for six-member and larger households.

Retired persons will benefit from a provision of the bill that grants an income tax exemption on the first \$7,200 of income less social security and railroad retirement from both public and private pensions. The exemption would be granted only in cases where total income is less than \$13,000.

Other provisions of the bill will create a \$140 tax credit for members of the Minnesota National Guard; allow a retroactive carryforward of the feedlot credit; increase from 1 to 10 acres the homestead allowance for purposes of "circuit breaker" property tax refunds; revise the distribution of a portion of the taconite production tax; and adjust the funds for payment of the taconite homestead credit.

Bill provides encouragement for small business

Small businesses in Minnesota will be aided by a measure passed this year by the legislature. The bill, S.F. 1450, creates a small business division within the Dept. of Economic Development. In addition, the bill also provides for the creation of a Small Business Advisory Task Force. Under the measure, a comprehensive analysis of methods to coordinate and expand activities of state agencies in the promotion and development of small businesses will be undertaken. The primary duty of the Task Force will be to advise the Commissioner of Economic Development and the legislature on structuring and allocating resources to the new small business division. A sunset provision is incorporated in the bill that sets an expiration date of July 1, 1979 for the Advisory Task Force.

Schools get \$15.7 million in extra aids

The Minnesota legislature appropriated an additional \$15.7 million to the state's public schools for 1978-79. One of the major spending measures of the session, the school aid bill provides \$4.6 million in basic per-pupil aid, \$3.7 million for school districts with declining enrollments, and \$3.1 million for special education programs. The spending increase brings the total state expenditure on primary and secondary education for the biennium to \$1.7 billion.

A key provision of the bill raises the basic aid formula for local school districts from \$1,090 to \$1,095 per pupil unit for the 1978-79 school year. The figure will be increased to \$1,150 and to \$1,220 for the following two years.

In addition to the change in the basic aid formula, state

aid will now be apportioned on the basis of the average enrollment for the past 3 1/4 years instead of the past 2 years. This provision is intended to assist school districts that have experienced rapidly declining enrollments.

The special education portion of the bill increases the amount the state will pay toward salaries for special education teachers from 65 percent to 69 percent, with a maximum of \$12,000 per teacher.

Bill bans state funds for abortions

A bill that restricts use of state funds for abortions for women on medical assistance was among those approved by the 1978 Legislature.

Under the bill state funds could be used to pay for abortions only under these conditions:

- if the life of the woman is in danger;
- if the woman is the victim of rape and it is reported within 48 hours;
- if the pregnancy is the result of an act of incest which has been reported to police.

The bill was one of the most hotly debated items during the 1978 session. Opponents of the measure said that abortions should have been allowed under additional conditions and that the law would discriminate against poor women. Supporters opposed additional "loopholes" and argued that if they were approved the bill would not effectively stop use of state funds.

Family planning gets \$1.3 million

Under a measure passed by the 1978 Legislature, a total of \$1.3 million will be made available to cities, counties, and non-profit organizations for use in pre-pregnancy family planning.

The bill, however, prohibits state funds from being allocated to any agency which also performs abortions. The bill also prohibits family planning counseling for school age minors and requires that parents or guardians of a minor be notified when an abortion or sterilization is recommended.

New buildings to cost \$119 million

Almost \$119 million in appropriations was approved by the 1978 Legislature for construction of new state facilities in the coming biennium.

Among the major items in the bill were:

- \$11.5 million for a new state office building in Duluth;
- \$8.7 million for a new 165 bed state hospital at St. Peter;
- \$2.1 million for a new Dept. of Natural Resources regional headquarters center in Grand Rapids; and
- \$2.9 million to construct a visitor center at Ft. Snelling.

While funding for a \$19 million veterinary medicine facility at the University of Minnesota was eliminated, over \$35 million was appropriated for U of M construction and improvements.

Almost \$4 million was included in the bill to remodel state buildings to improve handicapped access.

To finance the construction the legislation authorizes \$106 million in general revenue bonds. General funds provide an additional \$6 million and proceeds from dedicated receipts would provide about \$7 million more.

Consumers to be represented in rate cases

A bill which provides for representation of consumer interests in utility rate-setting cases was okayed late in the 1978 Legislative session.

The bill appropriates \$300,000 to the Consumer Services Division in the Dept. of Commerce. The funds will be used to hire professional rate analysts to represent consumer interests in complicated rate-setting procedures. The bill also creates a citizens board of nine members to advise the department. The composition of the new board is geographically balanced with at least one member required to be from each congressional district. The bill also states that the board should include at least two farmers and that no more than six of its members should be of the same political party.

Products liability laws revised

Damages awarded in products liability cases will come under new guidelines following passage of new legislation this session.

The new law sets a limit of \$50,000 on the amount of damages that can be stated as sought. Plaintiffs could still sue for additional damages but no specific amount could be stated — only that recovery of "damages in excess of \$50,000" is sought.

The law also reduces the statute of limitations in such cases from six to four years.

Another major feature of the new law is a provision that requires that percentages of fault be attributed to each party. If certain defendants should prove unable to pay any damages, others would be responsible according to their percentage fault. However, any defendant whose percentage fault was less than that of the plaintiff would only be responsible for that portion of the fault attributable directly to him.

Aid to non-public schools passed

Minnesota's non-public schools will receive \$2.6 million in aid under a bill (S.F. 1722) approved by the legislature this year. The measure was designed to bring state law into conformity with recent court decisions regarding the use of public funds for non-public schools. The bill provides \$2.6 million for aid to private schools in the 1978-79 school year. The bulk of the appropriation, \$2.5 million, will be used for text books, standardized tests and health services in non-public schools. The bill also appropriates \$90,000 in additional funding for non-religious private schools with small enrollments. Approximately \$1.5 million would be available for guidance and counseling services in the 1979-80 school year.

Appropriations bill okayed

The omnibus supplemental appropriations bill, commonly referred to as the "garbage bill" because of its many provisions, was approved by a conference committee on the last working day of the session. The bill, with appropriations totaling \$6.5 million, then received final passage by both bodies of the legislature and was sent on to the governor.

The measure (H.F. 2527) appropriates money to various state agencies for the remainder of the biennium. Some of the major provisions include: a \$153,892 appropriation to the Minnesota Historical Society for the maintenance and operation of the James J. Hill House in St. Paul; an increased promotion budget for the Economic Development Dept. amounting to \$633,000; and a decision to use \$1.3 million to help transport handicapped people in the metro area. Under the measure, Project Mobility, which provides non-emergency transportation, will get 80

percent of the money appropriated to the Metropolitan Transit Commission for transporting the handicapped. The remaining 20 percent would be spent on other methods of transportation.

Another major provision provides \$1 million to cover the costs of maintaining highway patrol troopers in west central Minnesota during the powerline dispute.

Campaign finance law amended

Minnesota's 1974 law to provide public financing for campaigns for legislative and state constitutional officers was amended by the 1978 Legislature in an attempt to bring the law into compliance with a recent federal court decision.

Two basic changes were made in the law. The first was a change in the distribution formula for candidates for the legislature. Previously such funds were allocated on a statewide basis according to the indications of party preference on the check-off form. Since many more state residents checked off the Democratic-Farmer-Laborer party, all DFL candidates automatically received more state funds than Independent-Republican candidates. The new distribution formula instead allocates funds on the basis of percentage of check-offs for each party in each district.

The second change involves a new provision in the law that requires that any candidate who receives public funds also agree to accept the spending limits imposed by the law. This provision was expanded to include those candidates whose supporters claim income tax credits, since such funds are an indirect means of public finance. A candidate who does not intend to abide by spending limits is required to notify his or her supporters that they may not claim tax deductions under the new law.

The basic system for public financing of elections remains unchanged. Taxpayers can still designate that \$1 from their income tax return go to support public funding.

Buy American

A bill that directs the state Commissioner of Administration to grant contract preference to American made products gained approval by the legislature this year. Under the bill, all state government agencies must purchase American made products if they are available in sufficient quantities, and if the price is not "unreasonably" higher, or the quality substantially less, than foreign products. The new policy will be effective July 1, 1978.

Urban rehabilitation

A bill that would delay increased taxes on certain rehabilitated housing was passed by the legislature. Under the bill, no increased value would be assessed on improvements made in inner-city rehabilitation projects for five years. To qualify, the building must be more than 25 years old and must contain more than three rental units, the rehabilitation must be completed within one year, and the project costs must exceed 60 per cent of the assessed value of the building. The measure is intended to increase incentives for corporate investment in urban housing rehabilitation.

Tenant rights

In the area of landlord-tenant law, the legislature passed a bill to strengthen the provisions of the Tenant Remedies Act. The measure is intended to make it easier for a tenant

to commence legal action when the landlord does not make necessary repairs. Under the bill, tenants in communities without housing codes will be permitted to use the provisions of the Tenant Remedies Act, which gives tenants the right to bring suit in cases of health and safety code violations as well as in certain other specified situations. In addition, the bill now covers oral as well as written contracts and rental agreements.

Energy bill

In its final form, the Omnibus Energy bill contains several measures directed at residential energy conservation and the promotion of alternative energy systems.

In the area of residential energy conservation, the bill directs the Department of Administration to promulgate minimum energy efficiency standards for existing residential buildings. Beginning October 1, 1979, a disclosure statement will be required at the point of sale on the extent to which a residence complies with these standards. A list of the building's structural and energy use characteristics must also be provided to the buyer.

Rental property that is in use between the months of November and April would also be subject to energy conservation requirements. All such rental property will have to meet minimum standards for caulking and weatherstripping by January 1980, and additional energy efficiency standards by July 1983. Also included in the bill is a consumer protection measure that will establish insulation product and application standards.

In the area of alternative energy, the bill will exempt solar, wind and agriculturally derived methane gas systems from increased property tax assessments. Several provisions to encourage the use and development of solar energy are also included in the bill. They will provide for solar energy zoning and planning ordinances, establish procedures for granting solar easements, and require that the Metropolitan Council consider access to sunlight in its land use plans.

Determinate sentencing bill approved

A compromise measure designed to set prison sentencing guidelines for trial court judges was given final approval by the 1978 legislature. The bill (S.F. 65) had been approved in widely differing versions by both the House and Senate in 1977 but no compromise was agreed upon.

A conference committee was appointed early this year to work out the differences. The bill, as it emerged from the conference committee, sets up a nine member commission to establish sentencing guidelines by Jan. 1, 1980. The commission will be made up of representatives from courts, public defenders, prosecutors and the public. The sentencing judge could then deviate 15 percent from the sentence recommended by the commission's guidelines. One of the primary aims of the bill is to set more uniform sentencing patterns throughout the state. Another provision contains a "good time" procedure whereby an inmate's sentence could be reduced by one day for every two days of good behavior.

Elections to fill U.S. Senate vacancies

A new law, which requires that a special election for any U.S. Senate vacancy be held in November of the same year (unless the vacancy occurs after August 1st), was approved by the 1978 Legislature. Under the law a new

provision requires special elections in odd-numbered years when vacancies occur.

The change shortens the length of time a person can be appointed to fill a vacancy to a maximum of 15 months' (which could occur if the vacancy was created in August after the deadline had passed for the November election that year.) The minimum time before a special election would be three months — in a case where a vacancy occurred late in July and the election was held the following November.

Previously a person could be appointed by the Governor to serve until the next general election. Vacancies which occurred shortly after one general election would not be filled by election until almost two years later.

Mandatory retirement compromise approved

Legislation was approved this year that would prohibit mandatory retirement before the age of 70 for most occupational categories after June 1, 1980. Prison guards, fire fighters, police officers, teachers, pilots and those earning more than \$27,000 annually are exempted from the new law. The measure also requires that employers notify employees at least 90 days in advance of the employees designated retirement date of their option to continue employment. The employee must then respond to the notice within 30 days or the right to continued employment may be waived.

Electronic funds transfer approved

After a stormy legislative history a bill requiring banks, savings and loan associations and credit unions to share their electronic banking facilities was finally passed. Former governor Wendell Anderson had vetoed similar bills twice during his governorship. Last year legislators in both bodies thought that the measure had passed only to discover, after the end of the session, that the language in the Senate and House versions was not identical.

Other provisions of the measure would allow all financial institutions to establish remote electronic teller facilities. Customers would then be able to deposit and withdraw money in grocery stores, department stores, shopping malls and other retail locations. Although some savings and loan associations already have the electronic banking devices, also known as electronic financial terminals or EFT's, under the measure they would have to share these with banks and credit unions by March 1, 1979. The bill applies only to off-site locations. Consumers would use coded cards and punch private codes into the machines to link the transaction to their home bank.

Family violence problems addressed

Several bills passed by the legislature this session address the problem of family violence. One measure, S.F. 318, provides special procedures for cases involving the beating of a spouse or another member of a household. Under the bill a policeman would be allowed to arrest an individual without a warrant if the officer had probable cause to believe the person had assaulted his or her spouse. It would not give the policeman the option of giving the person a citation to appear in court. In addition, if a person is convicted of assaulting his spouse and the court stays the sentence, the court may condition the stay upon the defendant's participation in a counseling program selected by the court.

Another measure, S.F. 1689, amends last year's Battered Women Law. The bill will allow the funding of more than four emergency shelters, if funds are available, and provides for education grant money to be used by the commissioner to produce educational and promotional materials to encourage the development and use of emergency shelter services. The bill also provides for the evaluation of data on battered women and for evaluating the programs.

The legislature also passed a bill (H.F. 1786) requiring social service agencies receiving a report of child abuse to notify the local police department. The measure provides for the confidentiality of police report records, except to the prosecuting authority.
